Sir,

In producing herewith 02 (two) arrested accused persons namely (i) Amar Nayak (24) S/O Bubna Nayak of Vill- Saragdih, PS- Barlanga, Dist- Ramgarh, JKD & (ii) Binoy Kr. Majhi (36) S/O Din Dayal Majhi of Vill- Tulin (Laxmi Mela), PS- Jhalda, Dist- Purulia and one seized Pick up Van bearing Regd. No. JH01BV 6960 loaded with (i) 60 Packet of IFFCO urea fertilizer (containing 45 kg Urea in each packet) and (ii) 10 packet SHAKTIMAN urea fertilizer (containing 45 kg Urea in each packet) to the effect that today (08/09/2019) at about 21:05 hrs. while myself along with C/804- Shyamapada Mandal, JC/1399- Sk. Sultan and JC/1511- Rajkishore Kumar was performing evening Mobile cum Naka duty near Subarnarekha bridge under Tulin O.P. (W.B.-Jharkhand Border) vide GDE No. 181 dt. 08/09/19 & C.C. No-1070/19 date- 08/09/19, received a source information that one Pick up Van bearing Regd. No. JH01BV 6960 was coming from Ranchi Jharkhand side towards Jhalda loaded with stolen fertilizer. Accordingly we took our position on road. At about 21:25 hrs. we noticed that the said vehicle coming from Ranchi side towards Jhalda and near Subarnerakha bridge we stopped the said vehicle and found that 02 (Two) persons are in the Pick up van and the Vehicle was loaded with (i) 60 Packet of IFFCO urea fertilizer (containing 45 kg Urea in each packet) and (ii) 10 packet SHAKTIMAN urea fertilizer (containing 45 kg Urea in each packet) and the vehicle was covered by a tarpaulin sheet. On asked the driver disclosed his identity as Amar Nayak (24) S/O Bubna Nayak of Vill- Saragdih, PS- Barlanga, Dist- Ramgarh, JKD and stated before me that the Pick up Van was loaded at Gola, Jharkhand and will be unloaded at Baghmundi. He also disclosed that one Tileswar Dey is the owner of the Pick up Van bearing Regd. No. JH01BV 6960 and will be unloaded as per direction of one Binoy Kr. Majhi (36) S/O Din Dayal Majhi of Vill- Tulin (Laxmi Mela), PS- Jhalda, Dist- Purulia who was present in the detained Pick up Van. On demand he failed to produce any valid papers in respect of the said vehicle and loaded Fertilizer. The driver also confessed that he along with owner of the vehicle and said Binoy Kr. Majhi were doing such malpractices for their wrongful gain. Hence, there is every reason to believe that the driver, owner of the said vehicle and one Binoy Kr. Majhi with ill motive were transporting fertilizer illegally in a clandestine manner and thereby liable for offence punishable U/S 379/411 IPC & Section 7(1) (a) of the Essential Commodities Act, 1955. As such at 21:45 hrs. I arrested the accused driver, Amar Nayak (24) S/O Bubna Nayak of Vill- Saragdih, PS- Barlanga, Dist- Ramgarh, JKD and his associate namely Binoy Kr. Majhi (36) S/O Din Dayal Majhi of Vill- Tulin (Laxmi Mela), PS- Jhalda, Dist- Purulia issuing arrest memo and inspection memo, in between 21:55 and 22:35 hrs. I also seized the Pick up Van bearing Regd. No. JH01BV 6960 loaded with (i) 60 Packet of IFFCO urea fertilizer (containing 45 kg Urea in each packet) and (ii) 10 packet SHAKTIMAN urea fertilizer (containing 45 kg Urea in each packet) under seizure list in presence of my accompanied staff. No public witness was available there.

I therefore pray that kindly start a case against (i) Amar Nayak (24) S/O Bubna Nayak of Vill- Saragdih, PS- Barlanga, Dist- Ramgarh, JKD & (ii) Binoy Kr. Majhi (36) S/O Din Dayal Majhi of Vill- Tulin (Laxmi Mela), PS- Jhalda, Dist- Purulia and (iii) Tileswar Dey (Owner of Pick up Van bearing Regd. No. JH01BV 6960) who are strongly involved in receiving and dealing with stolen property as per law and arrange for its investigation.
