1) 12 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.

I, ASI Joydeb Garai of Baglata I/C under Joypur P.S. do here by lodged a complaint against arrested accd. Person namely- Shitaram Kuiry @ Shital (39Yrs.) S/O Lt. Newalal Kuiry of Sidhi PS- Joypur Dist- Purulia to the effect that on 12.09.19 at about 17.15 hrs in course of my day mobile duty I received a telephonic information from a reliable source that one Shitaram Kuiry @ Shital S/O Lt. Newalal Kuiry of Sidhi PS- Joypur Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Baglata IC under Joypur PS and as per order of O/C Baglata I/C myself along with C/991 Aditya Seth, C/723 Mohan Das Murmu, NVF 948 Basudeb Mahato all of Baglata IC rushed to the spot for raid by Govt. vehicle. At about 17.45 hrs. myself along with force reached at of Sidhi and hold raid in his house of said Shitaram Kuiry @ Shital S/O Lt. Newalal Kuiry of Sidhi PS- Joypur Dist- Purulia found 12 pcs liquor bottles (DIL KHUSH @ per Rs-35/) at his own house and said Shitaram Kuiry @ Shital S/O Lt. Newalal Kuiry of Sidhi PS-Joypur Dist- Purulia and try to conceal himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person u/s 46 A(c) BE Act informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list and also made lebel duly sign by accd. person by available witnesses. I also made check list of him.

Hence I there for pray that a specific case may kindly be started against arrested accd. Shitaram Kuiry @ Shital (39Yrs.) S/O Lt. Newalal Kuiry of Sidhi PS- Joypur Dist- Purulia and arrange for its investigation.
