On 19.09.2019 at about 12.05 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Shibaram Mahato,HG TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC, entered the premises of Hajarat Ansari, S/O-Gafur Ansary of village-Velaidih P.S- Joypur , Dist- Purulia and found Hajarat Ansari, S/O-Gafur Ansari was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSSEDCL through CU cable white and Blue colour by means direct hooking to his house premises and connected load found 0.6 KW. As Hajarat Ansari, S/O-Gafur Ansari, committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Shibaram Mahato,HG TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC. The inspection team left the premises at 12.25 P.M.
