Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Dilip Kr. Mahato, S/O-Chandrakanta Mahato has committed theft of Electricity U/S-135(1)(a)(b) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 13.09.2019 I received a secret complain over telephone that Sri Dilip Kr. Mahato, S/O-Chandrakanta Mahato, Vill.-Ghutliya , PO-Chuna PS- Kashipur, Dist-PURULIA consuming electricity by means of tapping from incoming side of meter of WBSEDCL.

On the basis of said complaint at about 3.45 pm. I, Sri MrinalChowdhury, Divisional Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along And 1)Sri Dipak Kr. Bhowmik, SAE,Kashipur CCC

3) Sri Uttam Kr. Mahata ,TSH. GR-1 Kashipur CCC.

Entered the premises of Sri Dilip Kr. Mahato and inspected his installation in presence of villagers and Sri Dilip Kr. Mahato. During inspection it has been found that he is consuming electricity dishonestly by means of a loose wire connected with incoming point of meter and his load to stop registering actual consumption against consumer id 242063646

Total Load found approx 0.4 KW (fan-2 nos, bulb-2 nos)

Then we disconnect his permanent connection and seized the following articles.

- 1)Energy Meter-1 no, Make-GEC ALSTHOM , SL- NO-EE971368(5-20)
- 2)Bulb With Holder-1 no.

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 04.05 pm. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
