

Sub:-Prayer for starting a specific case against namely Dhananjay Bauri(45),s/o-Gopal Bauri of vill-Kalidaha(Huchukpara), PS-Kashipur, Dist-Purulia

Sir,

In producing herewith one accused namely Dhananjay Bauri(45),s/o-Gopal Bauri of vill-Kalidaha(Huchukpara), PS-Kashipur, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Twenty (20)liters ID liquor contained in a white plastic jarkin.
- One yellow nylon bag.
- 3) One white big polythin chat

I SI Prosanta Dutta of Kashipur PS do hereby lodged this complaint regarding that today (25.09.19) at about 18.45 hrs received a source information over telephone during evening mobile duty at Indrabil bazaar that the above noted accused person has been selling ID liquor illegally and clandestinely near Huchuk para more of Kalidaha village under Kashipur PS. On receiving the reliable source information I communicated with O/C Kashipur PS over telephone and as per his instruction I along with C/847-Uttam Hazra, C/347-Manas Pathak of Kashipur PS rushed to the spot to work out the information. On arriving to the spot at 19.05 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly at 19.15 hrs I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused in the seizure list and the label. One bottle of 250 ml ID liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness and accused on seizure list and label .After this I arrested that accused person namely Dhananjay Bauri(45),s/o-Gopal Bauri of vill-Kalidaha (Huchukpara), PS-Kashipur, Dist-Purulia after preparing proper memo of arrest at 19.55 hrs and observing all other formalities.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
