Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Santanu Bauri S/O- Bhisma Bauri of Village- Samda, P.O- Manbazar P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 02/09/2019 at about 1.50 pm, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Ramendra Narayan Sinha, SO, SLP, Purulia Region, WBSEDCL
- 2) Santu Dhari, SAE, Manbazar CCC, WBSEDCL
- 3) Sankar Ch. Mahato, LM, Purulia Region, WBSEDCL

entered the premises of Sri Santanu Bauri, S/O- Bhisma Bauri of Village- Samda, P.O- Manbazar, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from nearest LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos bulb
- 2) One no fan
- 3) Two nos CFL
- 4)

out of which we seized the following -

- 1) 1x2 core PVC cable (25 ft. approx) with hooking device.
- 2) 2x4 switch board (1 no)
- 3)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 2.00 pm on dated 2/9/19. The accused person has committed an offence U/S 135(1)(a) of the Electricity ACT 2003 (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
