I do hereby lodge a complaint empowered by enabling the Electricity act 2003

Purulia and inspected his/her premises and found that he was using electricity unwarrantably  
by direct from nearest LTCH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity
