Sir,

In producing here with one accused person Arjun Majhi @ Chhoto Bura (30) S/O Lt- Gati Majhi of Vill+PO- Jharbagda ,PS- Manbazar, Dist- Purulia along with following seized articles viz-


- (1) 21 (Twenty one) Ltrs ID liquor within a Jarikan
- (2) 12 pieces plastic glass
- (3) Sale proceed of Rs- 60/-

I ASI Subhendu Mahato of Manbazar PS do here by lodged a complaint against accused namely Arjun Majhi @ Chhoto Bura (30) S/O Lt- Gati Majhi of Vill+PO- Jharbagda ,PS- Manbazar, Dist- Purulia to the effect that today (13.09.19) at 18:35 hrs. I received a telephonic information from a reliable source that one Arjun Majhi @ Chhoto Bura (30) S/O Lt- Gati Majhi of Vill+PO- Jharbagda ,PS- Manbazar, Dist- Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD, vide Manbazar PS GDE No-512 Dtd 13.09.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1191 Subodh Hansda, JC/1395 Amit Kr. Dutta rushed to the spot for raid by Govt. vehicle. At about 19:05 hrs. myself along with force reached at Jharbagda village and held raid in the house of Arjun Majhi @ Chhoto Bura and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Arjun Majhi @ Chhoto Bura tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Arjun Majhi @ Chhoto Bura (30) S/O Lt- Gati Majhi of Vill+PO- Jharbagda ,PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
