Sir,

In producing here with one accused person Dudhnath Bauri (65) S/O Lt- Bolai Bauri of village- Chhotomanpur, PO - Bishri ,PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 25 (Twenty-five) Ltrs ID liquor within a Jarikan
- (2) 12 pieces plastic glass
- (3) Sale proceed of Rs-75/-

I S.I. Sujit Das of Manbazar PS do here by lodged a complaint against accused namely Dudhnath Bauri (65) S/O Lt- Bolai Bauri of village- Chhoto Manpur, PO - Bishri ,PS- Manbazar, Dist- Purulia to the effect that today (09.09.19) at 19:45 hrs. I received a telephonic information from a reliable source that one Dudhnath Bauri (65) S/O Lt- Bolai Bauri of village- Chhoto Manpur, PO - Bishri , PS- Manbazar, Dist- Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD, vide Manbazar PS GDE No- 329 Dtd 09.09.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1183 Subhas Kundu, JC/356 Amit Kr. Dutta rushed to the spot for raid by Govt. vehicle. At about 20:25 hrs. myself along with force reached at Chhotomanpur village and held raid in the house of Dudhnath Bauri and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Dudhnath Bauri tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Dudhnath Bauri (65) S/O Lt- Bolai Bauri of village- Chhoto Manpur, PO - Bishri, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
