SUB:- Written Complain against Sri Chandan Dutta.

Sir,

I, Sri Sourav Mukherjee, S/O Sri Bablu Mukherjee, aged about 28 years, residing at Vill+P.O+P.S – Manbazar, Dist-Purulia, PIN-723131 do hereby beg to state the following:-

1. That my father Sri Bablu Mukherjee is a Priest of the Kali Temple as well as Durga Temple in the Manbazar area for a long period of time.
2. That Sri Bablu Mukherjee is also serving as a Priest in the house of Sri Chandan Dutta, S/O Late Mahabir Dutta, Vill- Poddar Para, Gaja Gali, P.O+P.S- Manbazar, Dist- Purulia, PIN-723131.
3. That Sri Bablu Mukherjee was suffering from various health issues and therefore went to Cuttack for Medical Check-Up and hence was not present in the house. In this situation, on 13/09/2019 at around 12 noon Sri Chandan Dutta all of a sudden barged into my house and started to abuse me along with that was trying to force my father (Sri Bablu Mukherjee) to perform the activities relating to the Puja in the house of Sri Chandan Dutta even though several times my father told him that he is no more interested in doing the works. As we know that doing any form of work is the personal matter of a person and no one has any right to force anybody to do any work.
4. That when I tried to stop Mr. Chandan Dutta from using such abusive language, he pushed me and I crashed with a nearby table and got hurt.

Hence in light of the facts and circumstances I request your good office to register a First Information Report U/S 154 Cr.P.C, 1973 and Mr Chandan Dutta be charged U/S 323/447/506 Indian Penal Code, 1860.
