**Sub: - F.I.R. against MEGHU BOURI, S/O- LATE ABINASH BOURI of VILL-Charpatiya, P.O.- Nadiha, P.S.-Para, Dist-Purulia against theft of electricity.**

Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MEGHU BOURI, S/O- LATE ABINASH BOURI** of VILL-Charpatiya, P.O.- Nadiha, P.S.-Para, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 06.09.2019 at about 12.10PM, I GOUTAM KUMAR MANDAL, SM of Dubra Para CCC along with Avishek Das SAE(E) of Dubra Para CCC, Ramendra Narayan Sinha, SO, S&LP (Rt. DSP), Sankar Ch Mahato, LM, WBSEDCL inspected the premises of **MEGHU BOURI, S/O- LATE ABINASH BOURI** of Village-Charpatiya, P.O.-Nadiha, P.S.-Para, Dist-Purulia. During inspection it was found that the said **MEGHU BOURI** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 1 no ceiling fan of 60watts, and 02 nos LED of 9watts, approx load **0.078KW** for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 12:20PM.

As such **MEGHU BOURI, S/O- LATE ABINASH BOURI** of VILL-Charpatiya, P.O.- Nadiha, P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
