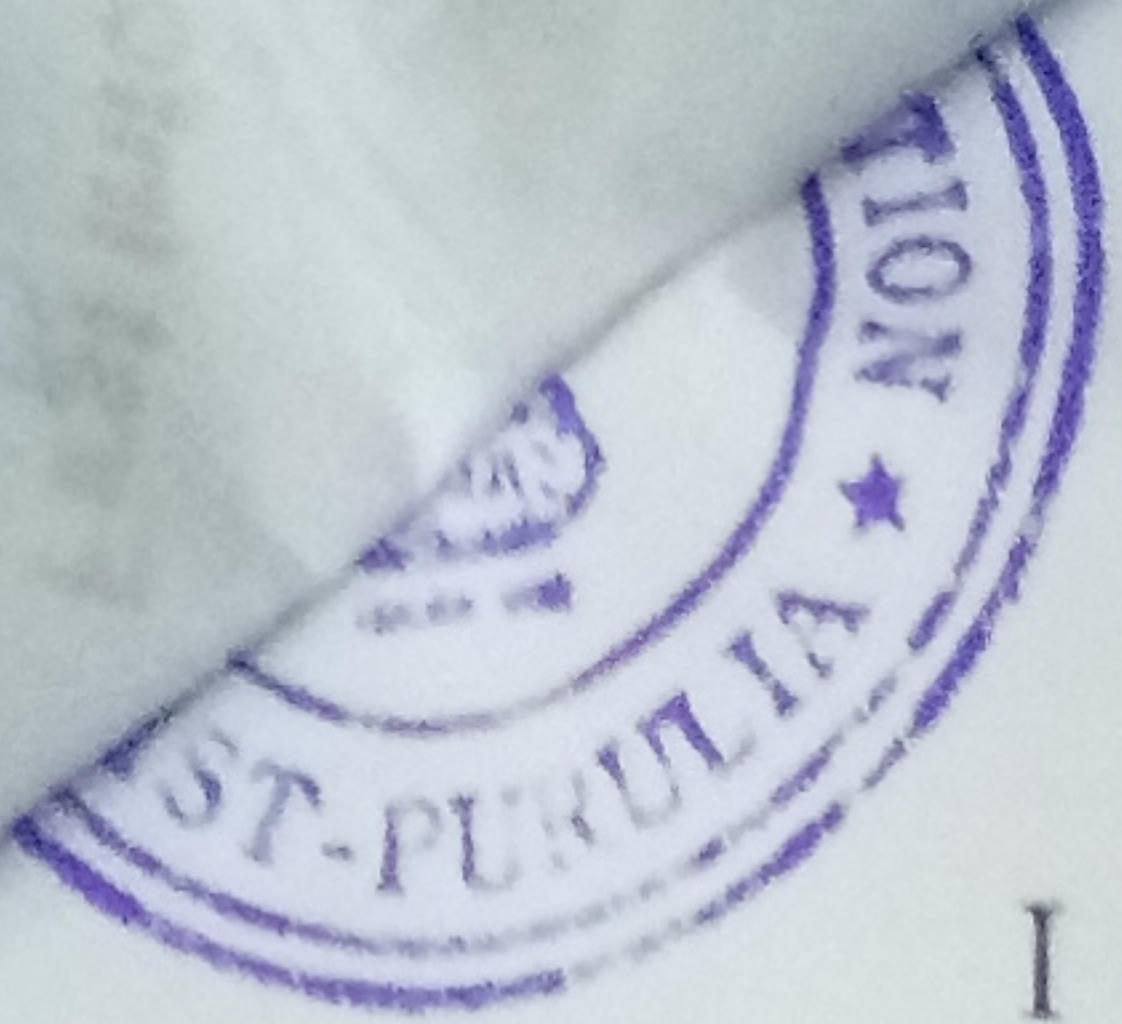

I SI Biswajit Banerjee, O/C Para PS do hereby lodge this case as suo motto against 150/200 unknown persons over the fact that, today was fixed for the election for formation of Sthayee Samity of Para Panchayat Samity ( vide Memo No 2295/17/BDO Para) and accordingly SDM, Raghunathpur was pleased to impose restriction/prohibition on assembly of five or more persons under jurisdiction of relevant panchayat samity office of Para, u/s 144(2) of CrPC and accordingly this order was made publicity on broad daylight by miking as well as by other means . Today (23.9.19) from 9:00 hrs officers force and CVFs were deployed to maintain L&O problem on several duty posts. I along with ASI Santosh Roy C/667 Chinmoy Bandyopadhyay , C/1038 Jaharlal Tudu, J/C 1431 Amit kr Sao, JC/1484 Dilip Majhi, JC/1341 Asim Ansary, JC/1525 Shankar Chandra, NVF/187 Upinath Tudu, NVF/664 Niranjana saren, NVF/367 Umesh Ch Besra NVF/729 Uttam Singh, LC/119 Maya devi Hembram and others was performing duty at the main gate of BDO office. At around 11:00 hrs a mob of 150/200 unknown persons under the banner of BJP forcefully reached near the main gate of BDO office. I asked them to stop but they did not pay any heed . I also made them aware in loud and clear voice about the order of Ld SDM, Raghunathpur regarding the restriction u/s 144(2) CrPC but they did not care, instead they started shouting at the peak of their voice and started abusing us in very nasty and filthy language. At that time one winning candidate Shyamal Roy was taking entry through the main gate . Seeing him the mob became more violent and to save him from their hands we made way for him. The lady candidates of BJP started assaulting him inside the premises of BDO Office and accordingly the deployed Lady police personnel prevented them and Shyamal Roy was made free to enter into the BDO office. But seeing Shyamal Roy saved , the mob started shouting and abusing and became too much agitated. On hearing them, as per previous briefing and direction my officers and force from the nearest posts came there. Finding no other alternative to stop, I declared that unruly mod as unlawful assembly and hearing this they became violent and started assaulting on duty police personnel by lathi , iron rod and by pelting stone. As a result ASI Falguni Sarkar C/ 307 Sasanka Shekhar Bai and CVFs namely Ujjal Dey, Balaram Mahato, Kajol Gorai, Pranab Mudi got injured. To control the mob we applied the minimum force and accordingly they could be dispersed. All the injured police personnel and CVFs got treated at Para BPHC.

Hence I do start this case as suo motto against 150/200 unknown persons vide Para PS Case No. 86/19 dtd. 23.09.2019 u/s 143/188/153/186/332/323/324/506 IPC as they prevented on duty police personnel from discharging govt duty, followed by assaulting police persons and making unlawful assembly by breaking the order of Id SDM, Raghunathpur, and directed SI Parimal Ghosh to investigate the case.
