Sub: To start a specific case against the unknown females of Bongabari village.

l SI Purnendu Datta of Purulia (M) PS, Dist-Purulia do hereby lodge a suo motto complaint after arriving at PS that today (02.09.19) I along with force was performing special mobile duty at PS area vide Purulia (M) PS GDE No 49 Dated 2.9.19 and CC No 2156/19 dated 2.9.19 received a telephonic information from duty officer of Purulia (M) PS regarding road blockade) near Ramakrishna mission Vidyapith on Purulia -Barakar Road (SH-5) and the road was obstructed by unknown dame of Bongabari village under Purulia (M) PS over the issue of recruitment of contractual cook, sweepers, night guard, warden and others of Bongabari Girls High school and Hostels and other local issues. Immediately after receiving the information, I along with force rushed to the spot with Govt. vehicle having Reg. No-WNF- 1225 at 10:35 hrs. As soon as I arrived at the spot and found that the road has been blocked by the rabble of about 150 unknown female of Bongabari village with placard and leaflets after forming unlawful assembly and saw that some of the female threatened the drivers of the vehicles with dire consequence with lathi if they tried to move the vehicles. The Vehicular traffic was totally disrupted. Subsequently I, informed the matter IC Purulia (M) PS. Other officers and lady forces arrived at the spot just after my arrival. On arriving at the spot and concomitant with lady constables, I tried to convince the road blockers that the Purulia -Barakar Road (SH-5) is one of the busy public lines of navigation of this district could not be blocked but they paid no heed to my words. I concomitant with lady forces started to disperse them from the road but the unknown blockers obstructed us in the discharge of our public functions. Later, BDO Purulia II arrived the spot and he also tried to convince them but they did not pay heed to the words of the BDO Purulia-II. After prolonged discussion and interposition of BDO-II the mob withdrew their blockade at 12.05 hrs and vehicular traffic became normal after our assiduous act. As the unknown females of Bongabari village committed offence u/s 143/186/283/506 IPC & 18 WB Highway Act. 1964 ergo, I submitted suo motto complaint before your good self to start a specific case against them.
