The above named complainant;

Most respectfully begs to state :-

- 1...That the complainant is the legally married wife of accused No. 1 Sk. Javed Akhtar. The marriage between myself and Sk. Javed Akhtar was solemnised on 17.4.2014 as per rites, customs and formalities of Islam Shariyat.
- 2...That after marriage the complainant went to matrimonial home and started to live with said Javed Akhtar in a joint family of Sk. Jakir. Hanifa Bibi, Sk. Salemohammad and Rahena Bibi. The houses of accused Nos. 6,7 and 8 are situated near by house of accused No. 1.
- 3...That after 4 months of the marriage accused nos. 1,2,3, demanded Rs. One Lakh from the complainant directing to bring the same from my father's house. <sup>her</sup> ~~my~~ father gave Rs. 80,000/- (eighty thousand) in two occasion but he could not give an Rs. 20,000/- to the accused No. 1,2 and 3 as a result of which the accused Nos. 1,2 and 3 with accused Nos. 4,5,6,7 and 8 started to abuse <sup>B</sup> ~~the~~ the complainant in filthy language insulting manner and also <sup>her</sup> ~~my~~ husband off and on used to assault <sup>complainant</sup> ~~me~~ at the instance and order of other accused persons but <sup>she</sup> ~~I~~ was there bearing all those torture.
- 4...That the all accused persons used to give threat to complainant that unless Rs. 20,000/- is paid. She will be driven ~~up~~ out for her matrimonial house but she was there.
- 5...That on 27.6.2019 the husband of the complainant and her father-in-law, mother-in-law, Debor Salemohammad, Nanaad Rehena Bibi and uncle in law, Sk. Nijam, Sk. Kamrul and Sk.

Sk. Mantu with making conspiracy assaulted the complainant and they drove out the complainant by kicking and snatching away all her ornaments golden and silver and Stridhan from their house, since then the complainant is residing at her father's house at village Tatari.

6...That the father and brother of the complainant called meeting at village Hutmura for two times and requested the accused persons to accept and keep the complainant at their house but they disclosed that Javed Akhtar wants to give Talak to the complainant and refused to accept the complainant, lastly the father and brother of the complainant returned to home with very sorrow and distress.

7...That the complainant is under physical and mental torture at the hands of all accused persons.

8...That F.I.R. was lodged regarding the above incident against the all accused persons before the Police of Purulia (M) P.S. but Police did not take any action against the accused persons and also did not investigate the matter.

9...That the complaint was lodged before Ld S.P. Purulia, but S.P. Purulia also did not take any action against the accused persons and so, this complainant compelled to lodge the complain against the accused persons with a prayer to treat this as F.I.R. and to send the same to the O/C Purulia (M) P.S. for investigation.

It is prayed that your Honour would be pleased to send this petition of complaint to the O/C Purulia (M) P.S. for investigation treating this as F.I.R. U/S 156(3) Cr.P.C.
