The above named complainant begs to state as follows :-

1. That the complainant is the legally married wife of the Accd No-1 and their marriage was solemnized on 07.7.2018 as per Muslim Law from the father house of the complainant at Vill. Chapra, P.S. Purulia(M) Dist.Purulia and the marriage was a socially arranged or negotiable marriage. And as per demand of the accd No-1 & accd No-2 himself, the mother of the complainant gave a cash of Rs.50,000.00(Rupees Fifty thousand) Five(5) vories of golden ornaments, Ten(1) vories of Silver ornaments, utensils and beding and the Dan Mohar have been fixed Rs 10,125.00(Rupees Ten thousand one hundred and Twenty five) only.
2. That the accd No-1 is the husband of the complainant Accd No-2 is the father-in-law, accd No-3 is the mother-

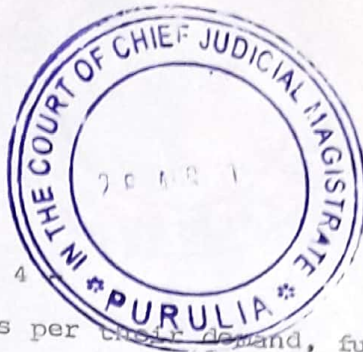
in-law, and accd No-4 to 6 are sister-in-law of the complainant, Be it mentioned here accd No 4 to 6 are married but they are permanently residing in their father house at vill. Hutmura.

3. That from the very beginning of starting of conjugal life, the accd persons were not happy with the dowries which were brought by the complainant to her matrimonial house over that issue all the accd persons used to fault her and also used to throw abusive and objectionable languages aiming the widow mother and brother's of the complainant.

4. That however the complainant was bearing all such torture on the exception that there would develop good sense in the mind of the accd persons but such ill treatment and torture started aggravated day to day and that in process the accd persons used to deprive the complainant with daily necessities and also they used to assault her off and on without any reason and also used filthy languages and/or detaratory words.

5. That after three (3) months from the date of marriage of the complainant. The accd persons after making criminal conspiracy the accd No-1 put pressure up on the complainant to bring a sum of Rs.50,000.00(Rupees Fifty thousand) from your father house, which was not paid at the time of marriage. And on continuous pressure she was compelled to intimate the said fact to his ~~wada~~ widow mother and brothers. Then mother and brother of the complainant

intimated that as per their demand, fulfilled their demands and no any question for dues. They also expressed their inability to meet any further demand.

6. That hearing the negative answers all the accd. persons became turiom and started abusing her and also deprived her will all necessities and in that process she was also assaulted by her husband (accd No-1) being instigated by other accd persons and such cruelly and harrassment day to day and made the life of the complainat hossiable and restless.

7. That in the month of Baishak 2019 the complainant was blessed with a female baby. After birth of new born baby the accd No-1 could not take which such in fact need. The complainant requested the accd-1 to arrange necessary requirement like Milk, medicine etc. but the accd No-1 refused. Then widow mother of the complainant had no make necessary arrangement for the new born baby.

8. That on 20th day of Jaistha 2019, the accd persons assaulted the complainant and drove her and her minor baby from their house. Then the complainant any how came to the house of her father at Vill. " Chapra " stated all the facts to her mother and brothers and since then the complainant and her minor daughter are in the house of her father.

9. That on 09.8.2019 the witness No- 2 & 3 took the complainant and her baby to the house of accd persons and requested then to keep them. But the accd persons

refused to keep the complainant and her baby without full fill the demand and the accd No-1 assaulted the complainat then any / how the complainant and witness(named above) came to chapra village. There after due to such assault the complainant was admitted to Deban Mahato sadar Hospital Purulia.

10. That on the following date i.e. 10.8.2019 the complainant had been to the Purulia(M) P.S.and lodged a complain before Police Station but police personal of Purulia(M) P.S. had not started any case and there after the complainant informed the matter to S.P.Purulia on 13.8.2019 but off No good.

11. That the accd persons have committed offence U/s 498A/323/34 I.P.C. for which they are liable to be convicted.

12. That the complainat is a poor and destitute lady and accordingly she is unable to procecute the case in the court in her own fund.

It is therefore prayed that your honour may graciously be pleased to send this petition of complain to the O/c Purulia(M)P.S U/s 156(3)Cr.P.Code for taking necessary steps.
