To The Inspector-in-charge Purulia (M) PS Dist- Purulia.

Sub: To start a specific case against the road besieger on Purulia –Barakar Road (SH-5) Sir,

I SI Subhas Malik of Purulia (M) PS, Dist-Purulia do hereby lodge a suo motto complaint after arriving at PS that today (20.09.19) I along with force was performing special mobile duty at PS area vide Purulia (M) PS GDE No 977 Dated 20.9.19 and CC No 2315/19 dated 20.9.19 received a telephonic information from duty officer of Purulia (M) PS regarding road blockade near Block More on Purulia -Barakar Road (SH-5) and the road was obstructed by approx 200 males & females of Bongabari village under the leadership of 1) Hrishikesh Mahato S/O Late Sashadhar Mahato and 2) Debi Rajak D/O Debu Rajak both of Bogabari village under Purulia (M) PS over the demand of arrest of two persons in c/w Purulia (M) PS Case no 226/19 Dated 20/09/19 U/s 302/120B/34 of the IPC and demanded that the police would not hold raid at Bongabari village in connection with the aforesaid case and other local issues. Immediately after receiving the information, I along with force rushed to the spot with Govt. vehicle having Reg. No-WB56C- 0018 at 08:35 hrs. As soon as I arrived at the spot and found that the road had been blocked by the rabble of about 200 unknown villagers of Bongabari village with wooden logs and barricade after forming unlawful assembly under the direct influence and direct direction of 1) Hrishikesh Mahato S/O Late Sashadhar Mahato and 2) Debi Rajak D/O Debu Rajak both of Bogabari village and saw that some of the villagers threatened the drivers of the vehicles with dire consequence with lathi if they tried to move the vehicles. The Vehicular traffic was totally disrupted. Subsequently I, informed the matter IC Purulia (M) PS. Other officers and lady forces arrived at the spot just after my arrival. On arriving at the spot and concomitant with lady constables, I tried to convince the road blockers that the Purulia -Barakar Road (SH-5) is one of the busy public lines of navigation of this district could not be blocked but they paid no heed to my words. I concomitant with lady forces started to disperse them from the road but the road blockers obstructed us in the discharge of our public functions as per direction of 1) Hrishikesh Mahato S/O Late Sashadhar Mahato and 2) Debi Rajak D/O Debu Rajak both of Bogabari village. Later, after the prolonged persuasion from us the mob withdrew their blockade at 11.35 hrs and vehicular traffic became normal after our assiduous act. As the 200 villagers of Bongabari village under the leadership of 1) Hrishikesh Mahato S/O Late Sashadhar Mahato and 2) Debi Rajak D/O Debu Rajak both of Bogabari village committed offence u/s 143/186/283/506 IPC & 18 WB Highway Act. 1964 ergo, I submitted suo motto complaint before your good self to start a specific case against them.
