Entered the premises of Susraj Ram & Banta Ram (USER) Vill. Sukanta Pally, P.S. Purulia (T), Dist- Purulia, having Consumer No. 200596546 Meter No. P2230462 and inspected his premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSSEDCL energy meter.

From the above by-passing system he uses the following electrical equipments.

- 1) Electric water pump (1/2 HP) - 01 no.
- 2) Color TV (SON) - 01 no.
- 3) Electric Fan (SON) - 03 nos.
- 4) Tube Light (AOL) - 02 nos.
- 5) CFL (09W) - 02 nos.

Out of which I seized the following.

- 1) PVC wire (1X2) Core - 40 ft (approx) along with Male - Female 2 pin plug.
- 2) Bulb with Holder along with Reflector - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/sign. The inspection team left the premises at 3:40 PM on 11/09/19. The accused persons has committed an offence U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
