Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Suraj Ram & Kanta Ram (USER) was ring electricity unauthorisedly i.e. bypassing of energy meter by arranging separate arrangement (bypass) and due to this reason they have committed theft of electricity U/s 135 of the electricity (Amendment act- 2007) on 11/09/19 at 3.20 PM I, Priya Ranjan (A.E & S.M., Purulia C.C., W.B.S.E.D.C.L.)

Entered the premises of Suraj Ram & Kanta Ram (USER) VIII Suganta patty, P.S. Purulia (T), Dist- Purulia, having Consumer No. 200546546 Meter No. P2230462 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Water pump (1/2 H.P.) - 01 no.
- 2) Color TV (SON) - 01 no.
- 3) Electric Fan (600) - 03 nos.
- 4) Tube Light (40W) - 02 nos; 5) CFL (09W) - 02 nos.

Out of which I seized the following.

- 1) PVC wire (1x2) core - 40ft (approx) alongwith Male - Female 2 pin plug.
- 2) Bulb with Holder alongwith Reflector - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 3.40 P.M. on 11/09/19. The accused person has committed an offence U/S135(I)(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
