OFFENCE COMMITTED : U/S 406/420/506 of IPC

The humble petition on behalf of your complainant Most respectfully begs to sheweth as follows:

1. That the complainant and the accused person are the inhabitants of the same village and residing within the jurisdiction of the Ld. Court.
2. That the petitioner is a peace loving and law abiding citizen of the country and on the other hand the accused persons are very desperate and dangerous type of people having no regards of law at all .
3. That the accused person is well known to the complainant and both are working at the same place mentioned herein that the accused person is also a Lottery Ticket Seller and the complainant purchased 5 Lottery Tickets of being No.70183 from the said accused on 28.03.2019 at about 1 P.M.
4. That on 30.03.2019 the said accused person came to the house of the complainant early in the morning and asked complainant's wife about the complainant in reply the complainant's wife informed the accused person that the complainant was at his working place and on hearing this the accused further asked about the Lottery Tickets and she again informed that the tickets are with the complainant and being confirmed the accused person directly went to the working place of the complainant and requested the complainant to give the Lottery Tickets just for verifying and accordingly the complainant on good faith handed over the said Lottery Tickets to the accused person.



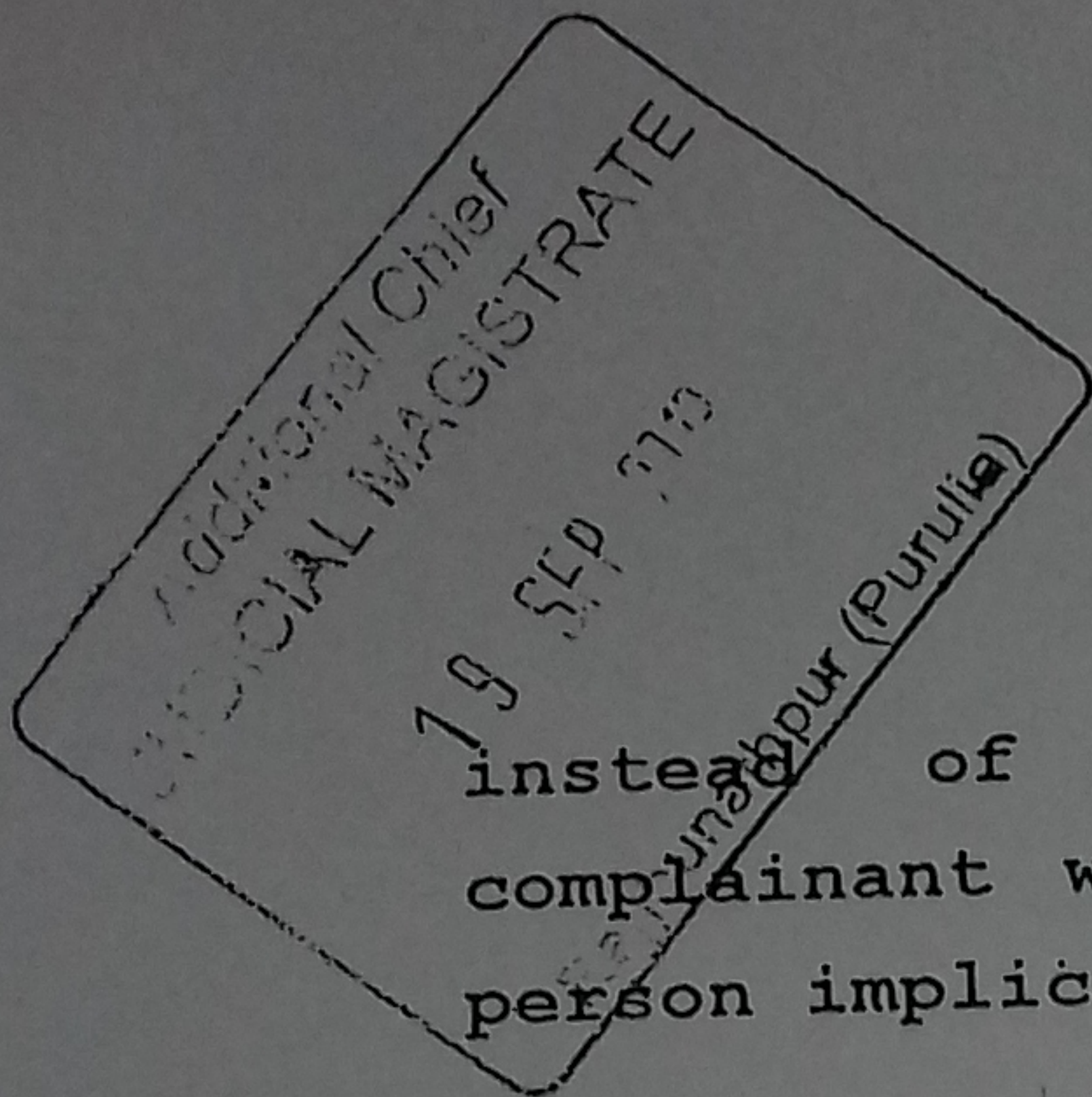

5. That after receiving the said Lottery Tickets the accused person told your complainant to wait a while till he returns but after a prolonged wait the accused did not return in the meantime the complainant came to know from his colleagues that the complainant has owned a sum of Rs.40,000/- from the said tickets which the complainant purchased from the accused person. Knowing it the complainant immediately contacted the accused person and requested him to pay the money which he owned from the said tickets, but the accused person flatly denied to pay the money nor agreed to return the said tickets.

6. That after returning home from the working place the complainant went to the house of the accused and requested him with folded hands to pay the money and also said that "my daughter's marriage has been fixed, kindly give me the money and it will help me extremely to fulfill the marriage ceremony of my daughter", but the accused did not pay any heed to the complainants request rather threatened with dire consequences.

7. That thereafter on 30.03.2019 in the evening the complainant informed the matter to the Villagers and on hearing everything from the complainant the villages called the accused on the same day and with the intervention of the villagers the said accused person admitted before them in writing to return the money to the complainant within 15 days from that day, but in spite passing of schedule period the accused failed to return the money and further asked for more time in writing for the same and time was allowed till 26.04.2019 but unfortunately till now after lapse of long period the accused person did not pay/return any amount to the complainant, but

instead of returning the money whenever the complainant went to ask for the money the accused person implicated the complainant in false cases.

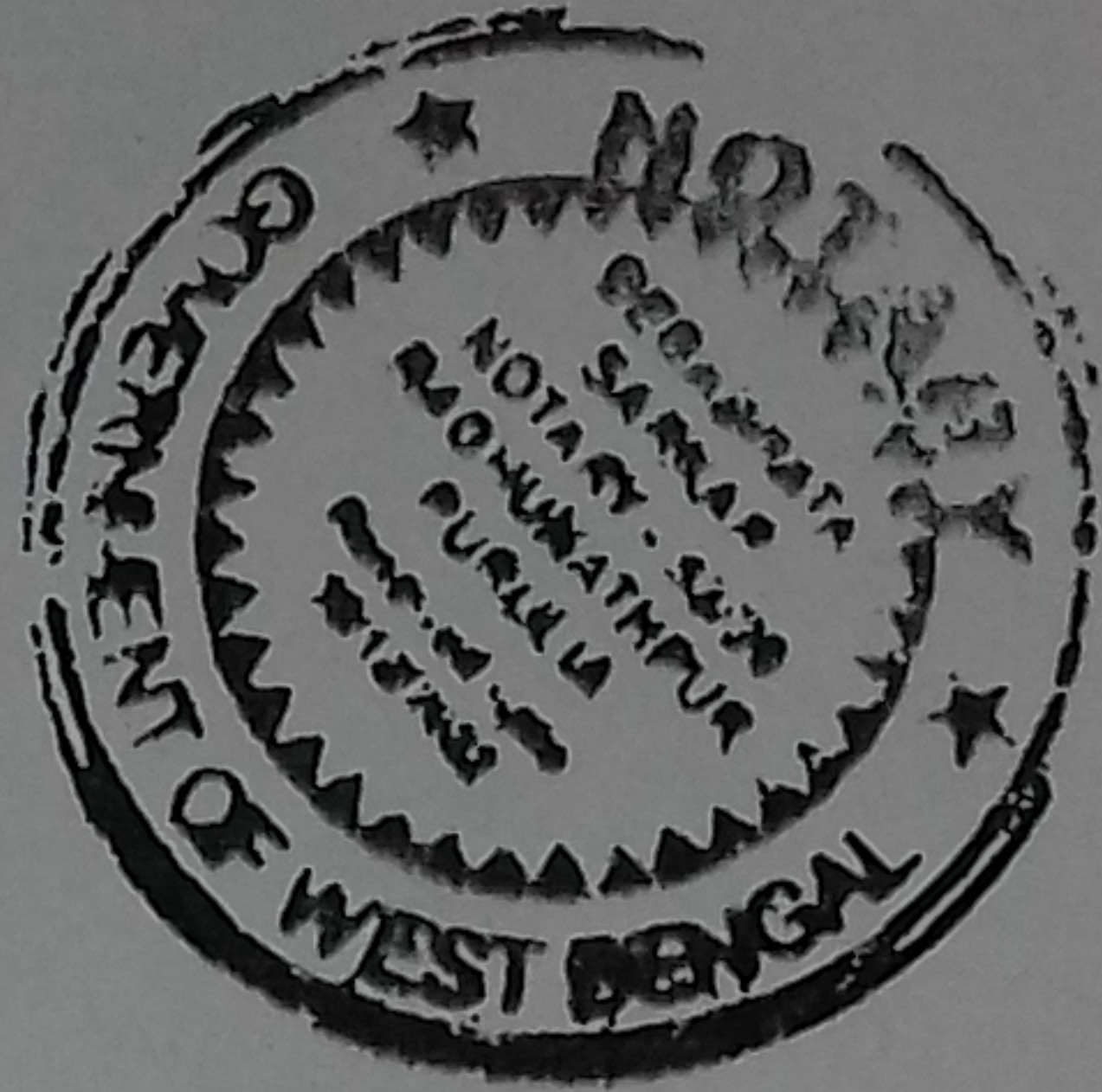
8. That finding no other alternative the complainant informed the matter to the Santuri Police Station but the police did nothing save and except advising the complainant to take shelter of open court of law and seeing the neglecting attitude of the local police authority the complainant is compelled to file this complain before the Ld. Court for seeking justice for the protection of life and property.
9. That the delay in registering the case is due to the expectation from the Police.
10. That details will be submitted at the time of the trial.
11. That the accused person has committed offence U/S 406/420/506 of IPC.

It is therefore prays that your Honour may graciously be pleased to send this petition of Complaint to the Santuri P.S. with a direction to treat the same as F.I.R. U/s 156 (3) of Cr. P.C. and to file its report to the Ld. Court for the ends of Justice.
