Sir,

In producing here with one arrested accused namely Bidyut Banerjee (35 Yrs) S/O Lt. Dulal Banerjee of Vill- SBI Para, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 14 bottles (in sealed condition) DIL SE country spirit, 375-ml each bottle, Rs-22 of each bottle.
- 2) 09 (Nine) pieces of plastic glasses and 05 (Five) empty bottles styled as DIL SE.

I ASI Phalguni Bandopadhyay of Adra PS do here by lodged a complaint against accused namely Bidyut Banerjee (35 Yrs) S/O Lt. Dulal Banerjee of Vill- SBI Para, PS-Adra, Dist- Purulia to the effect that on 22/10/19 at about 18:35 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Bidyut Banerjee (35 Yrs) S/O Lt. Dulal Banerjee of Vill- SBI Para, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house at SBI Para Adra and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at SBI Para Adra at about 19:25 hrs. and hold raid in the dwelling house of said Bidyut Banerjee and found that the said person selling liquor at his dwelling house and after seeing the Police party some person fled away and said Bidyut Banerjee has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Bidyut Banerjee selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Bidyut Banerjee (35 Yrs) S/O Lt. Dulal Banerjee of Vill- SBI Para, PS-Adra, Dist- Purulia under proper section of law.
