Sir,

In producing here with one arrested accused namely Gopi Bouri (29 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 18 bottles (in sealed condition) DIL SE country spirit, 375-ml each bottle, Rs-22 of each bottle.
- 2) 10 (Five) pieces of plastic glasses and 04 (Four) empty bottles styled as DIL SE.

I ASI Tapas Kr. Panda of Adra PS do here by lodged a complaint against accused namely Gopi Bouri (29 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia to the effect that on 02/10/19 at about 18:25 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Gopi Bouri (29 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house / Grocery Shop at Dalandanga village and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Dalandanga village at about 18:55 hrs. and hold raid in the dwelling house / Grocery Shop of said Gopi Bouri and found that the said person selling liquor at his dwelling house / Grocery Shop and after seeing the Police party some person fled away and said Gopi Bouri has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Gopi Bouri selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Gopi Bouri (29 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia under proper section of law.
