In producing here with arrested accused persons namely 1) Habib @ Mistri Sha (40 yrs) S/o- Lt. Harmuz Sha of Vill-Tumba-Jhalda, PS-Arsha, Dist-Purulia A/P Mukandapur, P.S- Joypur Dist.- Purulia 2) Ali Dilbahar Sha (26yrs) S/o- Yusuf @ Kalu Sha of Vill-Mukundapur, PS-Joypur, Dist-Purulia 3) Reaz Ali Sha (42yrs) S/o- Lt. Enahaque Sha of Vill- Joypur (Namopara), PS- Joypur, Dist- Purulia 4) Hazimuddin @ Hazu Sha (50yrs) S/O- Lt. Sadimani @ Sadim Sha of Mukundapur, PS- Joypur, Dist-Purulia along with seized articles (1) 01 (one) "Bhojali" iron made length approx 15 inch (2) 01 (one) " Bhojali" iron made length approx 14 inch with cover (3) One iron made Knife approx length 18 Inch (4) one iron made chopper length approx 14 inch (5) one iron made Sabol length approx 4 ft 4 inch (6) 03(three) Bamboo Lathi approx length 4 ft 6 inch. (7) one 3 (three) cell torch light (8) one 02(two) cell torch light (9) 02(two) nylon rope approx length 25 ft each (10) 10 pieces half burnt "Bidi" with one used match box under proper seizure list and I SI Gokul Ch. Ruhidas do hereby lodge a complaint against the above noted accused persons and 01 absconded accused namely Jamiruddin @ Jamir @ Halfa Sha (48yes) S/o- Lt. Harmuz Sha of Vill-Tumba-Jhalda, PS-Arsha, Dist-Purulia and 05/16 others to the effect that on 19.10.19 at about 21.45 Hrs received a credible information that a gang of dacoits with deadly weapons assembled at "Ghatbon" Sonajuri Jungle which is in the north side of Arsha- Begunkodor road in between Surgu river and Jibandih more, P.S-Arsha, Dist.-Purulia and they were preparing themselves for committing dacoity at Thakursima village under Arsha PS. This matter was informed to my O/C, Arsha PS and as per his direction the information was noted in GD Vide Arsha PS GDE No 641 Dated 19.10.19. As per kind order of O/C Arsha PS myself accompanied with Officer ASI Ullash Chandra, ASI Sushanta Mishra, all of Arsha PS and ASI (AB) Abhijit Guha of SAP 7th BN camp at Arsha PS and force namely C/-894 Dhananjay Mandal, C/-744 Sushanta Chakraborty ,C/-970 Dolon Biswas all of Arsha PS, SAP C/251 Pratik Karmakar, SAP C/- 191 Prasenjit Das both of SAP 7th BN camp at Arsha PS. vide CC No. 2723/19 dated 19.10.19. I along with officers and force immediately proceeded to the anticipated place of assembly to work out the information in Police vehicle (hired) vide no WB 68X/2741. We reached near Jibandih more at around 22.15 Hrs and leaving behind the Police vehicle started to proceed for the said place on foot. At 22.35 Hrs reached at the anticipated place and laid an ambush. In a glimpse of light we noticed that 10/12 persons assembled inside of "Ghatbon" Sonajhuri Jungle and those persons were whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up 04 (four) of them at 22.45 Hrs while the rest 05/06 managed to escape despite of a hot chase after them. On interrogation they disclosed their identity as mentioned above. On being asked the cause of their presence in this secluded place in this dead hour in night, they could not provide any satisfactory answers to the same. We told them we want to search them if necessary they can search us, but they told they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered i) 01 (one) "Bhojali" iron made length approx 15 inch from the back side waist of accused Habib @ Mistri Sha and 01 (one) iron made Sabol length approx 4 ft 4 inch in his hand ii) One iron made Knife approx length 18 Inch from the left side waist of accused Hazimuddin @ Hazu Sha and one 3 (three) cell torch light in his hand iii) one iron made chopper length approx 14 inch from the back side waist of accused Reaz Ali Sha and one 02(two) cell torch light in his hand iv) 01 (one) "Bhojali" iron made length approx 14 inch with cover from the left side waist of accused Ali Dilbahar and

and also searched the place of assembly using search light and found with 02(two) nylon rope approx length 25 ft each, 03(three) Bamboo Lathi approx length 4 ft 6 inch, 10 pieces half burnt "Bidi" with one used match box. Then after observing all formalities I seized the above noted weapons and articles from the possession of the above noted accused persons and the place of assembly under proper seizure list as alamat and duly labeled them in presence of available witnesses in between 22.55 hrs to 00.25 Hrs on 19/20.10.19. On interrogation they confessed their guilt and they stated that they have assembled there with 01 other namely Jamiruddin @ Jamir @ Halfa Sha (48 yrs) S/o- Lt. Harmuz Sha of Vill-Tumba-Jhalda, PS-Arsha, Dist-Purulia for committing house dacoity at Thakursima village. I am to note here that I conducted search & seizure in presence of Police Witnesses as because it was dead hour of night, a lonely place and also as per the information they assembled and making preparation for committing dacoity with deadly weapons which might endanger of life of Public witnesses, so I restrained from collecting public witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those person preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Habib @ Mistri Sha (40 yrs) S/o- Lt. Harmuz Sha of Vill-Tumba-Jhalda, PS-Arsha, Dist-Purulia A/P Mukandapur, P.S- Joypur Dist.- Purulia 2) Ali Dilbahar Sha (26yrs) S/o- Yusuf @ Kalu Sha of Vill-Mukundapur, PS-Joypur, Dist-Purulia 3) Reaz Ali Sha (42yrs) S/o- Lt. Enahaque Sha of Vill-Joypur (Namopara), PS- Joypur, Dist- Purulia 4) Hazimuddin @ Hazu Sha (50yrs) S/O- Lt. Sadimani @ Sadim Sha of Mukundapur, PS- Joypur, Dist- Purulia along with 01 other namely Jamiruddin @ Jamir @ Halfa Sha (48 yrs) S/o- Lt. Harmuz Sha of Vill-Tumba-Jhalda, PS-Arsha, Dist-Purulia and 05/06 others under section 399/402 IPC.
