In producing here with 03 (three) arrested accused person namely 1) Aswini Singh Sardar @ Hipa (23 yrs) S/O- Bhaktu Singh Sardar of Karakata, PO-Ghatbera, P.S.- Balarampur, Dist. Purulia 2) Ganesh Singh @ Pita Singh (26 yrs) S/O- Baishnab Singh of Vill-Parbaid, PO- GHatbera, PS-Balarampur, Dist-Purulia 3) Bashista Singh @ Babna (29 yrs) S/O- Lt. Debendranath Singh of Vill- Jugilong, PO-Jugilong, PS-Nimdihi, Dist-Saraikela Kharswan along with following seized articles viz-

- 1) 20 Ltrs (Approx) of country spirit contained in a container;
- 2) 250 grms (Approx) NISHADAL.
- 3) Two pieces of plastic Jar.

I ASI Swapan Nandi of Balarampur P.S do here by lodged a complaint against accused persons namely 1) Aswini Singh Sardar @ Hipa S/O- Bhaktu Singh Sardar of Karakata, PO-Ghatbera, P.S.- Balarampur, Dist. Purulia 2) Ganesh Singh @ Pita Singh S/O- Baishnab Singh of Vill-Parbaid, PO- GHatbera, PS-Balarampur, Dist-Purulia 3) Bashista Singh @ Babna S/O- Lt. Debendranath Singh of Vill- Jugilong, PO-Jugilong, PS-Nimdihi, Dist-Saraikela Kharswan to the effect that today (01.10.2019) at about 17:45 hrs I received a telephonic information from a reliable source that 3/4 persons have stocked some illicit liquor at Mirmi jungle area under Balarampur P.S & selling the same to innocent people for their personal gain. Accordingly I informed the matter to O/C Balarampur PS & as per his order I along with force held raid at the Mirmi jungle area (as shown by source) and found that 03 (three) persons were mixing the country spirit contained in 20 ltr. container, with some intoxicated substance (like white powder) having **acid smell which is likely to cause disability or death to human being**, beside the jungle area of Mirmi village. Accordingly I detained those 03 (three) persons who recognized themselves as 1) Aswini Singh Sardar @ Hipa S/O- Bhaktu Singh Sardar of Karakata, PO-Ghatbera, P.S.- Balarampur, Dist. Purulia 2) Ganesh Singh @ Pita Singh S/O- Baishnab Singh of Vill-Parbaid, PO- GHatbera, PS-Balarampur, Dist-

Purulia 3) Bashista Singh @ Babna S/O- Lt. Debendranath Singh of Vill- Jugilong, PO-Jugilong, PS-Nimdihi, Dist-Saraikela Kharswan. Being interrogated they confessed that the white powder like substance is **NISHADAL**, an intoxicated substance having acrid smell which is likely to cause disability or death to human being. It is also revealed during interrogation that above noted 03 (three) persons were selling the illicit liquor mixing with **NISHADAL** with a view to cause physical disability or death to human being. So, I arrested the above mentioned accused persons namely 1) Aswini Singh Sardar @ Hipa S/O- Bhaktu Singh Sardar of Karakata, PO-Ghatbera, P.S.- Balarampur, Dist. Purulia 2) Ganesh Singh @ Pita Singh S/O- Baishnab Singh of Vill-Parbaid, PO- GHatbera, PS-Balarampur, Dist-Purulia 3) Bashista Singh @ Babna S/O- Lt. Debendranath Singh of Vill- Jugilong, PO-Jugilong, PS-Nimdihi, Dist-Saraikela Kharswan maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused persons and available witnesses.

Hence, I, therefore pray that a specific case may kindly be started under proper section of law against arrested accused persons namely 1) Aswini Singh Sardar @ Hipa S/O- Bhaktu Singh Sardar of Karakata, PO-Ghatbera, P.S.- Balarampur, Dist. Purulia 2) Ganesh Singh @ Pita Singh S/O- Baishnab Singh of Vill-Parbaid, PO- GHatbera, PS-Balarampur, Dist-Purulia 3) Bashista Singh @ Babna S/O- Lt. Debendranath Singh of Vill- Jugilong, PO-Jugilong, PS-Nimdihi, Dist-Saraikela Kharswan and arrange for its investigation.
