Respected Sir,

In producing here with one arrested accused person namely Badal Singh Sardar (56 yrs) S/O- Late Biru Singh Sardar of Vill.- Chatourma, P.S.- Balarampur, Dist. Purulia along with seized 12 (Twelve) sealed country sprit bottles (DIL KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:45 hrs I received a credible source information that one person namely Badal Singh Sardar (56 yrs) S/O- Late Biru Singh Sardar of Vill.- Chatourma, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house village Chatourma under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for village Chotourma to work out the source information and held raid in the house of alleged person.

During search with the help of accompanying force, we found that the said person is selling country sprit bottles at his own house. On demand, he failed to produced any valid documents or License in respect of selling and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 12 (Twelve) bottles country sprit has been seized each bottles 600ml.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely

Badal Singh Sardar (56 yrs) S/O- Late Biru Singh Sardar of Vill.- Chatourma, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
