

2. That on 19.9.19 at about 9.00 a.m. the complainant was in the courtyard then all the accused persons come and appeared in front of the complainant and they restrained her by sawing iron rod, lathi and they started to abuse the complainant as witch (Daini). The complainant raised objection against the illegal activities of the accused persons, then the accused persons started to assault the complainant by iron rod, stone and lathi on the different part of the body of the complainant and for which the complainant sustained injury over her head and all over body. The complainant cried out for help and hearing the noise the witnesses named above came to the spot to save the complainant from the hand of the accused persons, then they also abusing them in filthy languages. The witnesses above named show the incident and the matter was also reported to them. The accused persons also defamed in the locality by the accused persons as the accused persons called as witch to the complainant.

3. That your complainant is old aged person and helpless person.

4. That thereafter the complainant reported the matter to I.C. Balarampur P.S. and with the help of the witnesses the complainant went to Hansgarh C.H.C. Balarampur for treatment and thereafter refer to D.M. Sadar Hospital, Purulia for C.T. Scan of brain for better treatment.

5. That after the occurrence the complainant inform the matter to Balarampur P.S. and thereafter inform the matter to S.P. Purulia but up till now no case has been
