Respected Sir,

In producing here with arrested accused person namely Dharani Singh (age-52 yrs) S/O-Lt. Lalit Singh of Vill-Boro Parashiya, P.S- Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today (08/10/19) at about 17:15 hrs received a credible source information over mobile during my Spl. mobile duty that one person namely Dharani Singh S/O-Lt. Lalit Singh of Vill-Boro Parashiya, P.S- Bandwan, Dist. Purulia selling illicit liquor in his house. Accordingly I, ASI Subrata Patra of Bandwan PS along with force namely C/42 Rajendra Murmu & C/72 Chiranjit Sarkar both of SAP 13th Bn. Camp at Bandwan PS left for Baro Parashiya village to work out the said source information vide Bandwan PS Spl. C.C No. 50/19, Dtd-08/10/19. Then, at about 17:45 hrs I reached at Boro Parashiya village and found the said person was selling Illicit Liquor at the courtyard of his house under Bandwan PS. So, with the help of accompany force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Being demand he failed to produce any valid license for selling liquor. Accordingly I seized Illicit liquor approx 20 (twenty) liters in a white plastic container after preparing proper seizure list duly signed by the witnesses and labeled and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Dharani Singh (age-52 yrs) S/O-Lt. Lalit Singh of Vill-Boro Parashiya, P.S- Bandwan, Dist. Purulia and arrange for its investigation.
