Sub: Prayer for starting a specific case against Tilak Murmu (35 Yrs) S/o- Lt. Nabin Murmu of Vill- Gurda, A/P Vill- Jharnakocha, PS- Barabazar, Dist- Purulla.

Sir,

In producing herewith the arrested accused person Tilak Murmu (35 Yrs) S/o- Lt. Nabin Murmu of Vill- Gurda, A/P Vill- Jharnakocha, PS- Barabazar, Dist- Purulia along with seized approx 48 liters of I.D liquor with in rubber bladder. I beg to submit that on 21.10.2019 at 23.30 hrs I got a source information while I was on mobile duty that one person may came from Gurda village side under Barabazar PS along with I.D liquor. Accordingly I inform the matter to I.C Barabazar PS and as per his direction in course of my mobile duty myself along with force left for that place for work out the information.

Accordingly, myself along force C/- 1147 Bappaditya Nandi & C/- 1228 Babulal Hansda left for Gurda village, PS- Barabazar with govt. vehicle having No- WB 56C 0014. At around 00.05 hrs reached at near Gurda more. After sometime around 00.10 hrs source indicated that, the person approaching towards Gurda more. As soon as he reached at Gurda more we apprehended him and encircled that.

I disclosed my identity to him & requested him to his identity. After a little pause he disclosed his identity as noted above. I inform him the cause of detention and requested him if he want he can search us. But he declined. I search him and found one rubber made bladder (Tube). It was defected that the liquid in side is having pungent smell & it appears as I.D liquor.

Accordingly, I seized the whole articles i.e. 48 liters under proper seizure list and marked as Exhibit- A; from the total materials I kept approx 01 liter as sample and mark as **Exhibit- A1**. The seizure list was prepared at P.O and duly signed by detained person and witnesses. As he failed to produce any documents, I arrested him at 00.25 hrs by issuing memo of arrest. I sealed and labeled the bottle. Then myself along with force, seized articles and all relevant papers and accused person left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused person Tilak Murmu (35 Yrs) S/o- Lt. Nabin Murmu of Vill- Gurda, A/P Vill- Jharnakocha, PS- Barabazar, Dist- Purulla for illegal trading of I.D liquor.
