I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that KARNA MALUHAR S/O LT. HARIPADA MALUHAR of Vill- NARAYANPUR, DHADKIDIH, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally by hooking from nearest LT OH line with the help of two core flexible wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 18.10.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 01:20 P.M., entered into the premises of KARNA MALUHAR S/O LT. HARIPADA MALUHAR of Vill- NARAYANPUR, DHADKIDIH, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- NARAYANPUR, DHADKIDIH, P.S Barabazar, DIST- Purulia.

During inspection, it was found that KARNA MALUHAR S/O LT. HARIPADA MALUHAR of Vill- NARAYANPUR, DHADKIDIH, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of two core flexible wire in his premises at NARAYANPUR, DHADKIDIH having connected load 0.081 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Fan (60 watts)
02. 01 no LED bulb (9 watts)
03. 01 no of two core flexible wire (18 Mtrs. App.) along a hooking device

Out of which I seized the following articles:

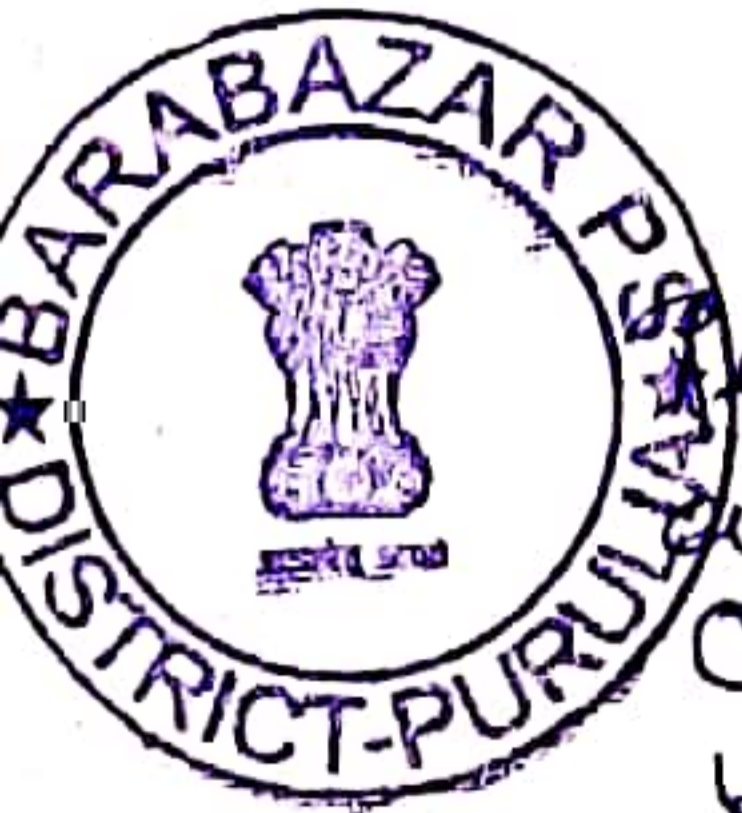
