

Sir,

With due respect and humble submission I beg to report you that on 14.10.19 at about 17.45 hrs C/ 932 Samiran Dey of Jamtoria I/C went to Burudih More for his personal work and when he reached at Fulberia village area found a paddy loaded truck heaving No. WB 55 - 5857 was parked on the middle of the road. Then he gave his identity as a police person and asked the driver of the said vehicle to remove the vehicle from the road but he refused to do so. Then Samiran Dey asked him to produce papers in respect of the vehicle. The driver could not produce any paper related to the vehicle. Then said C/932 Samiran Dey asked him to take the vehicle to Jamtoria I/C but the driver arrogantly refused to drive the vehicle. Finding no other alternative Samiran Dey tried to drive the vehicle for clear the road as well as to bring the vehicle to Jamtoria I/C but accidentally this vehicle has dashed to the Asbestos roof of the dwelling house of Manjali Besra W/O- Lt. Rabi Besra of Village Fulberia P.S. Boro Dist- Purulia as a result Asbestos roof of the said house got some damage but nobody received any injury. Over this incidence some unknown local people become furious and started assaulting him after binding him with a rope. As a consequences he got injury on his body. After getting the news myself along with force went to the spot and rescued him and bring him at Jamtoria I/C. I could not detain the said vehicle due to the agitated mob.

Therefore, I pray before your honour to start a specific case under proper section of law against the unknown accused persons who were involved in this incidence.
