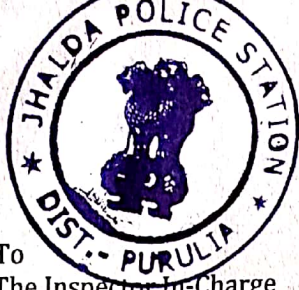

Date- 09/01/2021, (xv) 02 (Two) Instruments seem to be instrument of erasing , (xvi) (01(One) Container of black ink and (xvii) 100 ml liquid seems to be acid contained in a Jar and beg to submit that I ASI Habibul Rahaman Mondal along with C/696 Gorapada Pal, C/386 Sibendu Sinha, NVF/843 Bibekanda Mahato, and NVF/933 Abani Kumar was engaged in evening anti crime mobile duty at PS area vide CC No.2742/19 Dated 25/10/19. During Mobile duty at Mosina More at 17:45 hrs I received an information from my source that an illegal business is running by the official and management staffs of Jhalda Large Size Agricultural Primary marketing Co-operative Society Ltd. which is located at Anandabazar, under Jhalda Municipality PS- Jhalda, Dist- Purulia. I informed this to I/C Jhalda PS and as per his direction myself with help of my accompanying force reached at Anandabazar at 18:15 hrs and held raid in the Godown of Jhalda Large Size Agricultural Primary marketing Co-operative Society Ltd. and noticed that 10/12 persons were engaged in erasing/removing the writings of informatory details noted on packets of seeds and pasting forged label/ informatory details by using different instruments of forgery. Seeing the Police party all started run away but we managed to apprehend 03 (three) out of them. On being asked they disclosed their identity as noted above. On interrogation they stated that they along with other Official, managing staffs and casual workers of Jhalda Large Sized Agricultural Primary



marketing Co-operative Society Ltd. are dealing in this illegal business since long for their personal gain. They confessed that Jhalda Large Sized Agricultural Primary marketing Co-operative Society Ltd. is a Government under taking unit. It has some other branches also. In this organization they used to buy articles of agriculture like different kinds of seeds, fertilizers, pesticides from different companies and sold those articles to local farmers. They also disclosed that after expiry date of seeds and pesticides they remove/ erase the informatory details of manufacture company such as Lot No, Label No, date of testing, date of manufacture and date of expiry etc by using instrument of erasing and then they paste false or forged sticker or marker in place of original label. All the articles at this Godown at present are expired and they already removed original informatory details and changed by forged stickers some of those and others were going to be changed. On demand they failed to produce any license or valid document in respect of their authenticity of doing such act. In this way they cheated poor farmers by selling those expired articles. Hence, There is every reason to believe that (i) Dipak Ch. Kayal (56) S/O Lt. Ajit Ch. Kayal of Vill- Mosina, PS- Jhalda, Dist- Purulia A/P Sonarpara, Ward No- 04, PS- Jhalda, Dist- Purulia, Accountant of Jhalda Large Size Agricultural Primary marketing Co-operative Society Ltd. (ii) Ajit Nayak (20) S/O Krishnapada Nayak (iii) Sukra Nayak (20) S/O Lt. Lobin Nayak both of Vill- Latar, PO- Mosina, PS- Jhalda, Dist- Purulia, both workers of do along with the Secretary, the Manager, the Present and other official and management staffs and casual workers of Jhalda Large Sized Agricultural Primary marketing Co-operative Society Ltd. with ill motive dealing in this business in a clandestine manner and thereby liable for offence punishable U/S 468/471/409/420/120B IPC & 7 (1)(a) of the Essential Commodities Act, 1955. As such in between 20:05 & 20.25 hrs. I arrested above noted accused persons maintaining all legal formalities of arrest in presence local people and in between 20:35 hrs and 21:45 hrs. I also seized the above noted articles and documents under seizure list in presence of my accompanied staff and took one packet/ container as sample from each items.

I therefore pray that kindly start a case against (i) Dipak Ch. Kayal (56) S/O Lt. Ajit Ch. Kayal of Vill- Mosina, PS- Jhalda, Dist- Purulia A/P Sonarpara, Ward No- 04, PS- Jhalda, Dist- Purulia (ii) Ajit Nayak (20) S/O Krishnapada Nayak (iii) Sukra Nayak (20) S/O Lt. Lobin Nayak both of Vill- Latar, PO- Mosina, PS- Jhalda, Dist- Purulia, the Secretary, the Manager, the President and other official and management staffs and casual workers of Jhalda Large Sized Agricultural Primary marketing Co-operative Society Ltd. as per law and arrange for its investigation.
