In producing herewith the arrested accused person Jethu @ Disco Mahato (21), driver of BOLERO PIK -UP beari No. JH01BJ 9026, S/O- Agham Mahato of Vill- Haldatarh, P.S. Jhalda, Dist- Purulia and one seized vehicle BOLERO PIk UP bearing No. JH01BJ 9026 loaded with approx 2 MT of steam coal to the effect that today (20.10.19) at 16.05 hrs. 1, 5 Nimai Ch. Nemo along with C/571 Md. Hasib Khan, C/497 Ambuj Kr. Mandal, C/611 Jitendranath Pathak and NVF/039 La Kishore Mahato left P.S. for anticrime patrolling duty vide GDE No. 708 dt. 20.10.19 & C.C. No-2686/19 date- 20.10.1 During anti crime patrolling duty at about 19:45 hrs. while myself with force reached at Brajapur more on Jhalda-Gola ro received a source information that one vehicle BOLERO PIK -UP bearing No. JH01BJ 9026 was coming from Jharkhand si towards Jhalda loaded with stolen coal. Accordingly we took our position on road. At about 20.05 hrs. we noticed that the sa vehicle coming from Gola side towards Jhalda and at Brajapur more we stopped the said vehicle. We noticed one was a driver's seat and some others were standing on the vehicle. Seeing the Police party all jumped from the vehicle and statrunning towards jungle area. We rushed to them and after hot chase we managed to apprehend one. On asked he disclosed by identity as Jethu @ Disco Mahato (21), S/O- Agham Mahato of Vill- Haldatarh, P.S. Jhalda, Dist- Purulia and he was the driv of the vehicle. He also stated before me that the said vehicle was loaded from a Depot which is situated in a jungle und bordering area of Barlanga PS of Jharkhand and will be unloaded at Jhalda. On demand he failed to produce any valid paper respect of the said vehicle and loaded coal. The driver also confessed that he along with owner of the vehicle, Ashok Thaned S/O- Balaram @ Bhalu Thanedar, Pradip Saw S/O- Hiralal Saw of Jhalda, Naran Sing of Jharkhand, Lokesh Gorain S/O- I Guru Gorain of Vill- Brajapur, PS- Jhalda, Dist- Purulia, Budhu Gorain S/O- Durgacharan Gorain of do, Goutam Biswas S/C Uttam Biswas of do, Anadi Mahato S/O- Lt. Banamali Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia, Umacharan Mahato do, Mukesh @ Mansu Gorain S/O- Paresh Gorain of Bakad, PS- Jhalda, Dist- Purulia and 4/5 others were doing sus malpractices for their wrongful gain. On being asked he also stated that they collect steam coal from illegal coal mines Jharkhand state and stag in a jungle which is situated in a jungle under bordering area of Barlanga PS of Jharkhand and the transported steam coal at different places of Jhalda, Joypur and Kotshila area .He also stated that owner of the vehic BOLERO PIK -UP bearing No. JH01BJ 9026 is their leader and all are doing this as per his direction. Hence, There is eve reason to believe that the driver, owner of the said vehicle, Ashok Thanedar S/O- Balaram @ Bhalu Thanedar, Pradip Sa S/O- Hiralal Saw of Jhalda, Naran Sing of Jharkhand, Lokesh Gorain S/O- Lt. Guru Gorain of Vill- Brajapur, PS- Jhalda, Dis Purulia, Budhu Gorain S/O- Durgacharan Gorain of do, Goutam Biswas S/O- Uttam Biswas of do, Anadi Mahato S/O- L Banamali Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia, Umacharan Mahato of do, Mukesh @ Mansu Gorain S/O- Pares Gorain of Bakad, PS- Jhalda, Dist- Purulia and 4/5 others with ill motive were transporting and dealing in steam coal illegal in a clandestine manner and thereby liable for offence punishable U/S 379/411/413/414/120B IPC. As such at 21:05 hrs. arrested the accused driver issuing arrest memo and inspection memo and in between 21:15 hrs and 21:35 hrs. I also seized the vehicle BOLERO PIK -UP bearing No. JH01BJ 9026 loaded with approx 2 MT of coal under seizure list in presence of m accompanied staff. No public witness was available there.
