The said marriage was performed according to their customs prevailed in their community and the said marriage is still subsisting.
- 2. That at the time of marriage as per demand of the accused persons mother and brother of the complainant had to pay a cash of R.s 100,000/-along with other valuable articles and ornaments the value of those are R.s 50,000/- but the accused persons were not satisfied with either case or articles as given to the accused persons.
- 3. That after marriage the complainant was taken to her matrimonial home by the accused persons and started to reside there as husband and wife with the accused no. 1 along with other accused persons in the same mess and house.
- 4. That the complainant begs to submit that after six month of the marriage

accused no. 1 and 2 created pressure upon the complainant even they started both physical and mental torture upon the complainant. The complainant bearing all such torture stayed at her matrimonial home for good days though the accused persons did not supply daily necessity to the complainant.

That there after on 25.01.2019 accused no. 1 to 5 at the instigation of accused no. 6 told the complainant which and assaulted her with fist and blous and having heard such news brother of the complainant along with some persons of village Patamjuri came to the house of the accused persons on 31.01.2019 and requested the accused persons to keep the complainant property but instead of behave will they assaulted them and the complainant and drove out them from their house giving her threat that unless the complainant bring further demand of Rs. 1,00,000/- She would not be allowed to stay at her matrimonial home. There after the complainant is now residing at her fathers house.
- 6. That on 24.04.2019 the complainant was staying at her fathers house at village Patamjuri all the accused persons along with some antisocial gundas came there and entering into the house of Banku Majhi abused the complainant and assaulted her with fist and blous in which complainant sustain serious bodily pain.
- 7. That the complainant a helpless lady having no income of her own and not in a position to continue her case at her own.
- 8. That the incident was duly inform to the local P.S and there after to the







superintendent of police purulia on 06.09.2019 but neither of them had taken any step from their ends and accordingly the complainant is compelled to file this petition before the Learned court.

In the circumstances it is prayed that your Honour may be pleased to send the petition of complaint to the officer in charge at joypur police station treating the as F.I.R under 156(3) of Cr.P.C. for investigation.
