This is to inform you for the concern of utmost importance that one pole breakage has occurred at village - Darikuri P.S - Joypur on 20.10.2019 at about 7.30 pm due to illegal cutting down of stray wire attached to the said pole by Rampadar Gorain S/O Bidyadhar Gorain of village - Darikuri P.S - Joypur Dist - Purulia. The stray wire cut by the accused bears tension of Low tension line for each pole erected by WBS EDC. Due to this reason the pole got broke when a branch of tree fell on the low tension wire attached to the pole.

Moreover, when M/s Niladay Engg. Construction Company was appointed on the next day i.e. 22.10.2019 for executing the said work by the undersigned vide Purchase order no. S100526370 dated 21.10.2019. The accused intentionally created obstruction for executing the said job. The accused moreover stated to the labours of enlisted contractor that he would not allow any labour to execute the said work. For this obstruction consumers of Darikuri village, under Joypur P.S are in no power state from 21.10.2019.

This type of activity of Rampada Gorain S/o. Bidyadhar Gorain is seriously affecting our routine job for providing steady power supply to consumers of WBSEDCL and property damage to WBSEDCL to the tune of ₹ 21000 approx.

So therefore you are requested for taking lawful action against the accused and treat this complain as FIR.
