In producing here with one arrested accd. namely Upen Gorain (32yrs) S/O Lt. Amulya Gorain of Vill-Karkara, PS- Joypur, Dist- Purulia along with following seized articles viz-

- 1) 11 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Twenty pieces of plastic glass.
- 3) One White Plastic Bag

I ASI Joydeb Garai of Baglata I/C under Joypur PS do here by lodged a complaint against accd. namely - Upen Gorain (32yrs) S/O Lt. Amulya Gorain of Vill-Karkara, PS- Joypur, Dist- Purulia to the effect that on 22.10.19 at about 07.15 hrs. in course of my morning mobile duty along with force C/ 991 Aditya Seth, NVF- 601 Shibeswar Kuiry (vide Baglata IC C.C No -1590/19) I received a telephonic information from a reliable source that one Upen Gorain was stocked of country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Baglata I/C under Joypur PS and as per his direction I ASI Joydeb Garai along with force. At about 07.35 hrs he along with force reached back side of Hanuman mandir, Dihpara, Karkara and hold raid in the backside dihpara and found that said of - Upen Gorain (28yrs) S/O Lt. Amulya Gorain of Vill-Karkara, PS- Joypur, Dist- Purulia, stocked liquor at his own Counter/shop and seeing the police party some person fled away to concealed himself but I able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I seized 1) 11 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle and Rs-35 of each bottle. 2) Twenty pieces of plastic glass 3) One White Plastic Bag, after preparing proper seizure list and arrested him. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. persons and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Upen Gorain (32yrs) S/O Lt. Amulya Gorain of Vill-Karkara, PS- Joypur, Dist- Purulia and arrange for its investigation.
