Sir,

In producing herewith the arrested accused persons namely (1) Anil Majhi (28 Y) S/o- Late-Gobind Majhi of Vill-Jahajpur (2) Kartik Kumar (40 Y) S/o-Late Malku Kumar of Vill-Uparkahan, both of PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 13 (Thirteen) bottles Illicit country spirit "DILSHE" & 10 (Ten) bottles Illicit country spirit "DILKHUSH" (Total 23 bottles) strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label.

I ASI Ananta Kr De of Joypur PS here by lodged a written complaint against the above noted arrested accused persons to the effect that on today (22/10/2019) at about 19:15 hrs when myself along with NVF/-431 Nirmal Mahato, NVF/-803 Ankur Ch Mahato were performed special mobile duty, as per my source information I reached at Jahajpur village under Joypur PS and found that the above noted accused persons are selling country spirit "DILKHUSH" & "DILSHE" in the shop house of the accused Anil Majhi. On seeing Police persons they conceal their presence at that shop, but on searching we able to trace out them and also to found that 23 (Twenty Three) bottles of Illicit country spirit "DILKHUSH" & "DILSHE" which were kept conceal in a bag in the shop house. On being asked they disclosed their name and address as noted above. On interrogation they stated that they were selling Illicit country spirit liquor to the local people from the shop Jahajpur village after collecting from other side but on demand they failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that they were selling the Id liquor illegally without any documents. So I seized the same under proper seizure list & label duly signed by them and other available witness after taking 01 bottle of DILKHUSH & 01 bottle of "DILSHE" as sample out of 23 bottles of DILKHUSH & DILSHE. During further interrogation they confessed their guilt as such I arrested them today 22/10/2019 at 19:35 hrs as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely (1) Anil Majhi (28 Y) S/o- Late-Gobind Majhi of Vill-Jahajpur (2) Kartik Kumar (40 Y) S/o-Late Malku Kumar of Vill-Uparkahan, both of PS-Joypur, Dist-Purulia, State-WB u/s-46A (c) of the Bengal Excise Act 1909.
