To-day i.e on 21.10.19 at 14:35 hrs. I SI Partha Kumar Bhunia, O/C Manbazar P.S do hereby submit complaint Suo-motto against i) Swapan Mahato, S/O- Sasticharan Mahato 2) Avijit Mahato, S/O- Deben Mahato, (3) Ashok Gorai, S/O- Lt Indra Gorai, (4) Ashis Mahato, S/O-Lt Pagal Mahata, (5) Asim Bera, S/O- Ashok Bera, all are resident of vill- Sindurpur, PS-Manbazar, Dist-Purulia and other local villagers approx 100 to the effect that on 21.10.2019 at 08:50 hrs. received a telephonic information of accident and road blockade on Purulia-Manbazar Pitch road (SH-05) at Sindurpur village P.S. Manbazar dist.- Purulia. Accordingly noted the fact in general diary vide Manbazar P.S GDE No 773 dtd-21.10.19 and myself along with SI Mahadeb Rana, SI Soumyadeep Mallick, ASI Prasanta Mandal ,C/- 56 Bidesh Chakraborty, C/1316 Ujjwal Mandal, C/496 Prakash Mahato, C/905 Anil Ch Patra, C/1042 Prakash Mandal, JC/356 Amit Kr Dutta, JLC/1144 Sushila Mahato left P.S for Sindurpur village under Manbazar P.S After reaching there at about 09:15 hrs. I found that the road at Sindurpur village which runs Purulia to Manbazar had been blocked by above noted person and 100 others from 8.45 hrs. morning with Bamboo and wooden sticks. They Blocked the state highway road over the issue of accident. After reached the spot myself along with force including lady Police asked them about the incident and came to know that at about 08.45 hrs a SBSTC Bus dashed a woman namely Binata Gorai aged about 75 yrs and fled away and the said women expired on the spot. I have tried to pursue the agitators to withdraw the road blockade and help Police to remove the deadbody and to disperse the mob. It was also found that more then 30/35 different types of vehicles loaded with passengers and loaded goods and drivers including patients, minor baby etc. from Manbazar side and Purulia side were detained there from 08:45 hrs. morning and subjected to enormous sufferings for a long time. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles and passerby and thus generated danger and obstruction in public way over the issue of undue demands. Then I declared them unlawful assembly and asked them to dispersed. A tumultuous situation occurred and after my several request the agitators did not pay any heed to it I asked them to disperse but as we were scanty in number so I sought reinforcement. Meanwhile CI Manbazar and SDPO Manbazar with reinforcement and also official staff of BDO Manbazar-l arrived at the spot and after prolonged discussion with the agitators lastly they withdrew the road blockade at 14:00 hrs. and decamped calmly. Vehicular Traffic became normal.

On returning to P.S I Started Manbazar PS case No- 80/19 Dtd- 21.10.19, U/S- 143 /145 /149/150/151/186 IPC, Read with sec.18 of the West Bengal Highway Act. -1964 against the above named accused persons and other 100 local villagers. SI Mahadeb Rana endorsed to

investigate the case.
