Sir,

In producing here with one accused person Milon Sahish (26) S/O Ajit Sahish of village- Shyampur ,PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 15 (Fifteen) Ltrs ID liquor within a Jarikan
- (2) 7 pieces plastic glass
- (3) Sale proceed of Rs- 125/-

I ASI Chittaranjan Mukhapadhyay of Manbazar PS do here by lodged a complaint against accused namely Milon Sahish (26) S/O Ajit Sahish of village- Shyampur ,PS- Manbazar, Dist- Purulia to the effect that today (04.10.19) at 18:25 hrs. I received a telephonic information from a reliable source that the above noted person was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 163 Dtd 04.10.19 I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/56 Bidesh Chakraborty, HG/1419 Santanu Dutta rushed to the spot for raid by Govt. vehicle. At about 19:05 hrs. myself along with force reached at Shyampur village and held raid in the house of Milon Sahish and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Milon Sahish tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Milon Sahish (26) S/O Ajit Sahish of village- Shyampur ,PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
