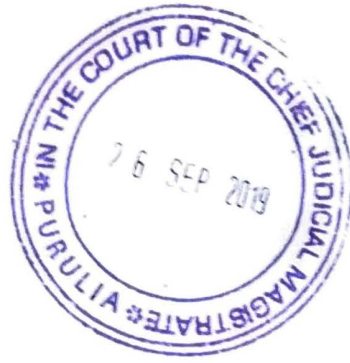

went to Thana on the very date but Thana did not take
any action against the accused rather they advised the
complainant to take shelter before the court of law the
complainant went to the door of S.P.Purulia but S.P.
reason best known to him did not take any action of
your petitioner is poor cultivator, he has no capacity
to bear the expenses of court proceeding at his own
cost.

Hence it is submitted that your honour may
kindly admit the 156(3)Cr.P.C.petition and to
start a specific case against the above named accused.
