- 1. That your complainet and the accused person both are resident of Vill. & P.O. Achkoda, P.S. - Neturia, Dist. - Purulia, (W.B.).


That complainant submits that Bindubasini Goswami (deceased) W/O. Lt. Bhuban Chandra of Vill. & P.O. - Achkoda, P.S. - Neturia, Dist. - Purulia, (W.B.) was the grandmother of the complainant and accused person who expired long ago leaving her four sons namely Harinarayan Goswami, Satyanarayan Goswami, Durgadas Goswami and Sibdas Goswami. Out of them Sibdas Goswami expired as bachelor. Thus share of Sibdas Goswami devolved upon his three existing brothers who subsequently also expired.

Be it mentioned that Harinarayan Goswami expired leaving behind accused person as his legal heir. Satyanaran Goswami expired leaving behind his two sons namely Goutam Goswami (deceased) and Gour Goswami. Similarly Durgadas Goswami expired leaving leaving behind the complainant and Subal Goswami.



In this context complainant submits that Bindubashini Debya had her landed property within Mouza Achkoda pertaining to Khatian No. 824as its sole owner and on the death of said Bindubashini Debya her sons and subsequently their legal heirs are in physical possession over the same leaving the lawful owner which largely known to the public of the locality.

- 3. That needless to say in search of some relevant documents partening to Khatian No. 824 of Mouza Achkoda your complainant had been to the Office of Concerning B.L. & L.R.O. Office, at Neturia whereupon complainant came across some of in respect of Khatian No. 824 of Mouza Achkoda and on thorough enquiry on 24/04/2019 the complainant became stunned to know that entire Khatian No. 824 which was standing in the name of Bindhubasini Debya has been converted in the L.R. Khatian No. 624of Mouza Achkoda in the name of "Uttameswar Goswami" being its sole owner. Being astonished the complainant thereafter informed the matter to all the actual owners of the property in Khatian No. 824 who became spellbound hearing the fact.
- 4. That on 29/.6/2019 morning accused Uttameswar Goswami gave out threat to the complainant and other co-sharers saying "বিন্দুবাসিনির সমস্ত সম্পত্তি আমার একা, আমার নিজের নামে খতিয়ান, আমি একা মালিক। ঐ জমিতে ঢুকলে কাউকে ছাড়বোনা, সবকে খতম করে দেব। আইন কানুন সব দেখা আছে। সব হাতের মুঠোয়। আমি যখন একক নামে রেকর্ড করতে পারি তখন সব কিছু করতে পারি ।"
- 5. That complainant and his other associates including witness Bo. 1 to 4 during their enquiry from concerning office, came to know that on the basis of fraudulent and forged documents and by practicing fraud representing himself to be the only heir of Bindubasini Debya. Accused Uttameswar Goswami has managed to get prepared the L.R. Khatian No. 624 in his own name from R.S. Khatian No. 824 by suppressing actual fact of legal heirs of Bindubasini Debya. It is abundantly clear that the accused Uttameswar Goswami has committed the offence to which he is punishable as per provision of law. Since due to such illegal act on the fault of the accused the complainant sustained damage and loss. More so the accused has committed enimical breach of trust with a view to illegal gain depriving the complainant and witnesses 1 to 4 from their lawful claim. In spite of such illegal act and also give out threat to the complainant and other share holders to face dare consequences if they ventured to raise any objection against such acts or to claim the property within alleged Khatian in his name.



6. That in view to bring the accused person into book the complainant lodged a written complaint with Neturia P.S. on 08/07/2019 against the accused for such illegal and ovate act, in which P.S. Concern assured the complainant to take legal appropriate action against the accused person but even passing of sufficient time the P.S. authority did nothing to that effect. So your complainant sent his grievance to the Superintendent of Police, Purulia vide Regd. Post on 19/07/2019but in vain till date which resulted the complainant to seek his remedy before Ld. Court.

Therefore on the set forth ground, petitioner prays before the Ld. Court to pass necessary order upon O.C. Neturia P.S. to investigate the case treating the instant petition as an F.I.R. U/Sec. 156(3) Cr. P.C.
