Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Narayan Ball (45) (Proprietor of Joy Bholenath Bhojanalay, at Parbelia Bazar,) S/O- Ananda Ball of Vill-Hijuli, PS-Neturia, District- Purulia with seizure of 21 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (22.09.19) at 18:35 hrs while myself, SI Kalyan Kumar Sakha, with force were performing anticrime Day mobile duty near Sarbari More that time received a source information that one Narayan Ball (45) S/O- S/O- Ananda Ball of Vill- Hijuli, PS-Neturia, District- Purulia has illegally stocked liquor in his Joy Bholenath Bhojanalay at Parbelia Bazar under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction, I along with force proceeded to Parbelia Bazar to work out the information. At 18:55 hrs after reaching at Parbalia Bazar held raid in the Joy Bholenath Bhojanalay of Narayan Ball and found that he was keeping / selling liquor which were kept in his Joy Bholenath Bhojanalay, on demand Narayan Ball failed to produce any valid documents/License in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 21 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Narayan Ball (45) (Proprietor of Joy Bholenath Bhojanalay at Parbelia Bazar,) S/O- Ananda Ball of Vill-Hijuli, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1140 Dayanoy Mahato and (2) C/382 Bipad Taran Chatterjee both of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Narayan Ball (45) (Proprietor of Joy Bholenath Bhojanalay at Parbelia Bazar,) S/O- Ananda Ball of Vill-Hijuli, PS-Neturia, District- Purulia u/s- 46 A(c) B.E.
