Sub: Complaint against (1) driver of truck bearing registration No – UP-65GT/9409 namely Mehi Lal Nisad (48) S/O- Ram Jiyawan Nisad of Parasultanpur, PS- Baxar, Dist- Jaunpur (UP) (2) Registered owner of truck bearing registration No – UP-65GT/9409 and (3) Owner of the coal, seized from truck bearing registration No – UP-65GT/9409 .

Sir,

In producing herewith one arrested accused namely Mehi Lal Nisad (48) S/O- Ram Jiyawan of Parasultanpur, PS- Baxar, Dist- Jaunpur (UP) along with seized truck bearing No – UP-65GT/9409, Engine No- ISBE591804081J63729237 & Cassis No- MAT541057J1J28165, loaded with steam/raw coal of 20 M.T. (approx) do hereby lodge a complaint to the effect that on the night of 19/10/19 I ASI Sujoy Kundu along with C/66 Kameswar Pandey C/1353 Atanu Ganguly and C/470 Somnath Nag all of Neturia PS were engaged in night mobile duty vide Neturia PS GDE No- 707 Dt19.10.19 & CC No- 2186/19 Dt. 19.10.19. In course of night Mobile duty on 20.10.19 at about 04:05 hrs when we reached near Subhas More ( Purulia -Barakar Road) under Neturia PS, I received an credible source information that one truck bearing No. UP-65GT/9409 loaded with illegal coal coming from Raghunathpur side and which will transport the same to Asansol side through Purulia - Barakar road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started Naka checking there to intercept the vehicle. During Naka checking we found that one truck which was coming from Raghunathpur side we managed to stop the said vehicle and found the vehicle was loaded with coal approx 20 MT, I asked driver to produce valid documents in respect of loaded coal as well as vehicle but he failed to produce the same.

So, there is reason to believe that the driver, registered owner of the vehicle and owner of coal have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they are trying to dispose of the same coal in a clandestine manner to Asansol side knowing it to be stolen, as per their regular practice.

Accordingly I seized the said truck bearing No – UP-65GT/9409 loaded with steam/raw coal of 20 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 04:05 hrs and 04:40 hrs, since no public witness was found. So the driver, registered owner of the vehicle and owner of coal has committed offence U/S- 379/411/413/414/120B IPC. During interrogation driver of the vehicle disclosed his name and address noted above and produced a driving license I also seized the same and arrested him. During the time of arrest maintained all formalities regarding arrest, informed ground of arrest.

Under the above fact and circumstances a specific case may kindly be started against the (1) driver of truck bearing registration No – UP-65GT/9409 namely Mehi Lal Nisad (48) S/O- Ram Jiyawan of Parasultanpur, PS- Baxar, Dist- Jaunpur (UP) (2) Registered owner of truck bearing registration No – UP-65GT/9409 and (3) Owner of the coal, seized from truck bearing registration No – UP-65GT/9409 U/S- 379/411/413/414/120B IPC..
