

Sub: Complaint

Sir,

In producing herewith one seized live wild animal seems to be Pangolin, having length 3.5 feet and weight about 25 KG under proper seizure list, I would like to inform you that, today (2.10.19) I, along with ASI Santosh Roy and C/307 Sasanka Sekhar Rai, C/30 Nimai Ch Ganguly and C/793 Prasanta Kumar Patra was performing mobile duty at JKD Purulia border. At around 20:15 hrs I received a credible source information that Rajesh Ansary, S/O Ujir Ansary of Vill Bahara, Para, Janardan Mahato s/o Suresh Mahato of Tadagram Para and Ukil Ansary of vill Bhelatar, PS Santaldih had contacted with some unknown persons of Chandankeyari area for buying a live pangolin near Hotel Paradise on JKD Purulia border near Darda under Para PS. Some persons would come from Chandankeyari side with the animal and they would receive that near hotel Paradise. Accordingly I informed the matter to you over mobile phone and you directed me to look into the matter.

We reached near hotel paradise and kept the vehicle in a hidden place. At around 21:15 Hrs we found three persons reached near the hotel . I personally know Rajesh Ansary and Janardan Mahato and accordingly could recognize them from distance. After 4/5 minutes two youths were seen coming from the back side of the hotel on feet and one of them was carrying a bag on his shoulder. When they came close we started to go to them and all of a sudden rajesh Ansary started shouting Police Police and all of them started running. We chased them but could not get hold of them, while running they left the bag. On searching the bag with some local witnesses we found a live wild animal seems to be Pangolin, having length 3.5 feet and weight about 25 KG inside the bag. Accordingly I seized the animal under proper seizure list in presence of local witnesses and police witnesses as noted in the seizure list from 21:45 hrs to 22:05 hrs and took the animal under our custody with caution and care to save its life and brought it to PS. The identity of the two youths who were coming to sell it could not be fixed up while we could identify the 3rd person who accompanied with Rajesh Janardan, as and Ukil Ansary of vill Bhelatar, PS Santaldih.

During enquiry it seems that they are habitual offenders of this business of wild life in clandestine manner. They kept the animal in such a bag for transporting so as to cause torture and injury to it and they have stolen it from jungle with a view to have a healthy profit by illegally selling by a chance system.

Hence I pray that a case may kindly be started under proper section of law.
