With due respect and humble submission, I beg to state that I the under signed Hassam Imam Ansari s/o- Jainul Ansari of Ukrid Basti, Bokaro Steel City, PS-Sector-12, Dist-Bokaro, Jharkhand informed you that I am the registered owner of vehicle having Registration No- JH- 09AH/7052 (Trailer-4018). On 28.10.19 at about 19:00 hrs when my said above noted vehicle coming from Barbil to Bokaro through Purulia- Ranchi Road and when it reached near Biplab Line Hotel at village- Rudra which falls under the jurisdiction of Purulia (M) PS, Dist-Purulia at that time one unknown vehicle coming from Chase More side and dashed my vehicle.
