Radhu Bauri of Vill- Metalsahar, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house / Shop at Metalsahar and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Metalsahar village at about 19:05 hrs. and hold raid in the dwelling house / shop of said Bhramar Bauri and found that the said person selling liquor at his dwelling house / shop and after seeing the Police party some person fled away and said Bhramar Bauri has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Bhramar Bauri selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.
