and inspected his premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCI energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 08 nos.
- 2) Electric Bath - 03 nos.
- 3) Color TV - 02 nos.
- 4) Water pump - 01 no.
- 5) CFL - 04 nos.

Out of which I seized the following.

- 1) PVC wire with by-passing arrangement - 15 ft (Approx)
- 2) PVC switch Board - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 3.35 PM on 05/11/19. The accused person has committed an offence
U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
