I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Parikshit Gope s/o- Mr. Rathulal Gope of village - Saldabra (Banstard) P.O. PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 11.11.2019 at about 01.10 PM I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Subhasis Mahato (OE) 2. Sri Yudhishthir Paramanik (H.G.TSH) entered the premises of Sri Parikshit Gope s/o- Mr Rathulal Gope of village Saldabra (Banstard), PS-Bagmundi Dist- Purulia and found Sri Parikshit Gope was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Parikshit Gope s/o- Mr Rathulal Gope committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato (OE) 2. Sri Yudhishthir Paramanik (H.G.TSH) The inspection team left the premises at 01.25 PM. Dt. 11.11.2019
