Respected Sir,

In producing here with one arrested accused person namely Amritanjan @ Jhablu Mahato (33 yrs) S/O- Ajodhya Prasad Mahato of Vill- Nekre, P.S.- Balarampur, Dist. Purulia along with seized approx 09 (nine) liters Country Sprit (ID liquor) with plastic Jarican and 15 pieces plastic glass. (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Amritanjan @ Jhablu Mahato (33 yrs) S/O- Ajodhya Prasad Mahato of Vill- Nekre, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at Nekre village under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Nekre village to work out the source information. Thereafter we reached at Nekre village at about 18:55 hrs as per source information and held raid in the house of Amritanjan @ Jhablu Mahato.

During search with the help of accompany with force, we found that the said person is selling country sprit in his own house. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized the said country sprit (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Amritanjan @ Jhablu Mahato (33 yrs) S/O- Ajodhya Prasad Mahato of Vill- Nekre, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
