Sub: Lodging F.I.R against Smt. Saroj Jaisawal, W/o. Lt. Bijoy Jaisawal for unauthorized use of Electricity by way of bypassing the Energy Meter u/s 135(i)(a) & 135 (i)(c) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC of WBSSEDCL do hereby lodge complaint against Smt. Saroj Jaisawal, W/o. Lt. Bijoy Jaisawal resides at Vill – Barabazar Road, Balarampur, Po. Rangadih, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in her residence by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSSEDCL.

Acting upon such information today on 13.11.2019 from 2.05 PM to 2.40 PM I, along with Jiur Rahaman Mondal, D.E.(E), Sri Ramendra Narayan Sinha, S.O. (Retd D.S.P.), Sri Sankar Ch. Mahato A.C.M., S&LP Unit, Purulia Region, Sri Manab Kr. Maji, J.E.(Gr-II) and other officials of WBSSEDCL has inspected the premises of Smt. Saroj Jaisawal and held raid after serving Notice duly received by the accused.

During raid and inspection it was detected that the accused Smt. Saroj Jaisawal is using electricity dishonestly by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSSEDCL. Through this bypass arrangement she is using 3 Nos 100 Watts Lamp, Ceiling Fan 2Nos, T.V. 1 No & 1 No. 9Watts LED Lamp having connected load 0.489 KW. The Service Connection of WBSSEDCL bearing Consumer ID : 242031287 stands recorded in the name of the accused, which has been disconnected on detection of theft of Electricity.

I prepared Inspection report in presence of the of the Accused and assessed the Load as 0.489 Kw. Details have been mentioned in the Inspection Report and duly signed (L.T.I.) by the Accused.

I directed Sri Sankar Ch. Mahato, A.C.M. to disconnect the Service Connection of the above stated Consumer ID. Accordingly he disconnected the aforesaid Service Connection and removed the bypass arrangement.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature (L.T.I.) of the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
