Sub: Complaint against Rajib Mondal (37Yrs), S/O- Manik Mondal of Vill- Nekra PS - Boro, Dist - Purulia along with seized article and seizure list to start a case U/S- 46AA of the Bengal Excise Act - 1909.

Seized Article

- 1) 10 Ltrs (Approx) of country spirit contained in a white colour Jariken.
- 2) 100 grams (Approx) NISHADAL, contained in a plastic carry bag.
- 3) 08(Eight) pieces of Plastic glass.

Respected Sir,

In producing herewith one arrested aced. person Rajib Mondal (37Yrs), S/O- Manik Mondal of Vill- Nekra PS - Boro, Dist - Purulia with seizure of approx 10 ltrs of illicit spirit in a Jariken and 100 gram Nisadal in a plastic carry bag, from his residential house from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (25.11.19) during mobile duty in between 20.05 hrs to 20.35 hrs acting on a secret source information I apprehended the above noted person at village Nekra at his house and found that above noted seized ID Liquor which was kept in his house. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his house containing approx 10 ltrs illicit spirit in a Jariken and 100 gram Nisadal in a plastic carry bag. I asked him about the white powder like substance and accordingly, detained Rajib Mondal recognized it as "NISHADAL" (approx 100 grams contained in a plastic), an intoxicated substance having acrid smell which is likely to cause disability or death to human being. Accordingly I seized the same under proper seizure list in presence of witnesses which is enclosed herewith. As such he was arrested at 20.45 hrs u/s 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 ml (approx) taken out in a separate bottle as sample with sealed & labeled.

The above noted arrested aced Rajib Mondal (37Yrs), S/O- Manik Mondal of Vill- Nekra PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession and selling of intoxicating liquor after mixing NISHADOL without obtaining from a licensed vendor and in contravention and he committed offence u/s 46 AA of the Bengal Excise Act - 1909.

It may note here that during raid (1) C/1361 Munsii Kamal Hossian, (2) C/ 11 Asim Roy accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 AA of the Bengal Excise Act - 1909 may kindly be started against Rajib Mondal (37Yrs), S/O- Manik Mondal of Vill- Nekra PS - Boro, Dist - Purulia.
