At the onset, the undersigned would like to acknowledge you regarding the ongoing Government works in Karrior Irrigation Scheme under Purulia Irrigation Division. It has come to information of the undersigned in writing by the Junior Engineer, Karrior Irrigation Scheme that one miscreant named, "Laxmipada Mahato, C/O: Late Sambhu Mahato, Vill: Baragata, P.O: Mahatomara, P.S: Jhalda, Dist: Purulia" along with 2 other women of his family have not only misbehaved with the "Government officer on Duty" but also wrenched the diary book the officer was carrying. Details of the incident have been given in writing by the Junior Engineer, Karrior Irrigation Scheme, which has been attached along with this correspondence for your ready reference.

Even after this heinous incident, the officer tried his best to resolve the matter through dialogue but his efforts went invain. It transpires from the incident that they do not abide by any law & order.
